Whether Skill or Strength is Superior in Prize Ring to be Settled.

DIFFERENCE BETWEEN THEM.

Both Are Adepts at Their Own End of the Fistic Game—Battle Now Seems Quite Probable.

If Tommy Ryan and Jack Root should come together in the ring, as now seems extremely probable, two mooted questions of the pugilistic arena should be decided one way or the other.

One point at issue is the old belief of the London ring, that a man weighing 150 pounds is heavy enough to fight any man regardless of weight. The other is the long discussed problem of whether science is superior to strength in a modern battle or whether the reverse is true.

Ryan and Root will represent two different styles of fighting. Ryan is essentially the clever boxer-clover in the sense of being able to land a hard blow as well as to spar. Root is a cool-headed, able ringmaster, but is not believed to possess the speed and skill of Ryan.

He can spar as well as any man now in his own weight division, is speedy on his feet and is particularly good at the counter punch. He is a fighter with extreme ability in leading a long string of victories.

Ryan is the crafty ring general of exceptional swiftness on his feet, with a knockout for an object of his aim.

THE BERKELEY STUDENTS IN FOR IT

Letters Sent Them Declaring That They Have Been Dropped From Military Roll.

NAMES ARE NOT GIVEN OUT.

Are Now Dealing With War Department and There Can be No Yielding.

Berkeley, Cal., Nov. 7.—The riot among the students of the University of California last week over the military order to march into the class room for a non-sensational sequel today when President Wheeler sent letters to a large number of students declaring that they had been dropped from the military roll.

In the notice the dismissed students are given until Wednesday to make a written report explaining their actions. President Wheeler stated today that he was acting under direction of the war department.

"The students did not know that they were dealing with a war department order when they acted as they did last Wednesday," said President Wheeler. "This is unfortunate, as there can be no yielding in this matter."

As yet the names of the students to whom notices have been sent have not been given out. The orders that caused the students to rebel last week are part of the regulations laid down by the war department for governing lecture courses in schools where military science is taught. The disturbance was participated in by nearly 1,000 students, and Prof. W. A. Setchel, who attempted to stop the riot, was jeered at and struck on the head with clubs.

GOOD SHOTS WILL GET BETTER PAY.

Scheme to Increase Interest in Marksmanship Among the Soldiers.

Money Instead of Medals.

Expert Riflemen Will Receive an Increase of Two Dollars Per Month The First Year.

Washington, D. C., Nov. 4.—The advisability of increasing interest in marksmanship among the soldiers of the United States army, has been recognized by the army authorities and, in connection with the work of the national board for the promotion of rifle practice with the militia and civilians, it is interesting to note that there is a plan on foot to increase the pay of soldiers in the regular army who qualify as expert marksmen.

In the infantry and cavalry the expert rifleman now receives one dollar a month extra for the year in which he qualifies as an expert, but after once winning this inadequate prize there is no additional reason for the men to keep up their standing. It has therefore been suggested that there should be a fair-sized increase of pay for qualifications of this kind and a small one for each succeeding qualification thereafter. In this manner the man's pay would be increased each year according to his accuracy in marksmanship, and eventually the amount received would become commensurate with the value to the government of a skilled shot in comparison with a poor one.

With this view in mind, it has been recommended that each enlisted man on his first qualification as an expert rifleman receive a monthly increase in his pay of two dollars and an additional increase of one dollar per month after every yearly qualification as an expert marksman so long as his service remains continuous. It is further recommended that each enlisted man on his first qualification as sharpshooter receive a monthly increase of one dollar and an additional increase of 50 cents per month for every yearly qualification as sharpshooter so long as his service remains continuous. It is also suggested that instead of donating medals at the various competitions as the sole prize for the ones winning thereat, the following increases in the enlisted man's pay in addition to the medal prizes be authorized so long as the winner's service remains continuous:

For division rifle, carbine and pistol practice—to the winner of the gold medal, a monthly increase of three dollars; first silver medal, two dollars; second silver medal, \$1.50; third silver medal, one dollar; except that no man may receive the increase cited above for more than one medal in any one year.

For army rifle, carbine and pistol competition—to the winner of the gold medal, a monthly increase of five dollars; first silver medal, three dollars; second silver medal, \$2.50; third silver medal, two dollars; with the proviso that no soldier may receive the increase for more than one medal in any one year.

The retention of the medal prizes is considered as advisable on sentimental grounds as it furnishes a tangible evidence of individual fitness but in itself it is not regarded as an incentive to the best sort of continuous effort. The proposed action in any case would require legislative action and, for any reason, these recommendations are not adopted, Congress will probably be asked to increase the pay of expert riflemen and sharpshooters of the infantry and cavalry branch to the amount now received by the first class and second class gunners of the artillery corps.
