# **GRANTS NEW TRIAL** TO ARTHUR BROWN

Supreme Court Reverses Judge Armstrong on Technical Ground.

SENTENCED FOR FORGERY.

Trusted Clerk Drew Check for 86,125 And Signed Employer's Name To it-Insanity Not Proven.

On a technically, in no way concorned in the question as to whether Arthur Brown forged a check or did not, or that he is or was insane or is not and was not, is the ground upon which the supreme court reversed the trial court before which Arthur Brown

was convicted of forgery and sentenced to serve three years in the State prison. According to the opinion, Brown is entitled to a new trial, thrown was a trusted employe of the Itah Apex Mining company, a Maine corporation, He was charged with forging and uttering a check against the company's funds on deposit in the Commerciaal National bank. The check was drawn for \$6.125, W. C. Orem's one drawn for \$6,125. W. C. Oren's ame was signed to the check and trown endorsed it. In the taking of Brown endorsed it. In the taking of trestimony, it was proved that the corporation was formed under the laws of Mains. Judge Armstrong overruled an objection by the defense to the introduction of testimony by the prosecution in proof of the allegation that the Utah Apex Mining company was a corporation doing business in this state. This fact was assigned as an error in the appeal to the higher court and the assignment of error is conceded by the assignment of error is conceded by the court in its final decision,

ARRESTED BOARDING TRAIN.

Brown was arrested by Captain Burblidge for the offense just as he was about to board an O. S. L. train for the northwest. The arrest took place May 21, 1996, and Brown was convicted on Oct. 16, of the same year and sentenced to serve these very same and sentenced to serve these very same and sentenced to serve these very same and the contract of the serve of the ser tenced to serve three years at labor in the state prison 10 days later. One ground of the defense was that Brown was insane, which a lunacy examina-tion found to be not true.

#### AFTER SMOKY CHIMNEYS.

Acting Mayor Davis Will Take Steps To Abate Troublesome Nuisance.

Acting Mayor A. J. Davis has received from numerous persons complaints regarding violation of the smoke ordinance, which, appear to be more numer-

ance, which, appear to be more numerous at the present time than at any season heretofore. The ordinance regulating the operation of smoke stacks within the city was amended about one year ago to provide the citizens better protection against those who operated smoke stacks which emit large quantities of heavy, black smoke. However, since the ordinance was placed upon the city's law books in new form, not a single prosecution is of record.

It is probable that the city engineer's office will be asked to detail its photographer to go about the city to secure photographs of the most vicious violators of the ordinance. These photographs will be used as evidence in court prosecutions which will probably follow. Acting Mayor Davis has determined to take up the matter with the chief of police and an officer will perhaps be detailed to look after this class of cases for some time to come in the hope of doing away with the nulsance.

The additions join the present Monticello forest on the northeast and are located entirely in San Juan county. The total area of the forest is now raised to 215,668 acres.
