DEMOCRACY AND DISCIPLINE.

THE explanation which the war department of England gives for the mutinous spirit exhibited in the army is that there is getting to be too much intelligence in the ranks. The soldiers are becoming educated in the principles of human freedom. In other words they are growing democratic.

This is no doubt as true as it can be. It was proven long before the pets of the English army shocked her Majesty hy refusing to obey orders, that an educated brain will not endure abject anbordination, that it will face death with a more invincible front than it will the thought of being a slave.

* To the mind of the Queenithis is no doubt an appalling discovery. She cannot hope with, free education scattered broadcast over the land, to close the ranks of her army against it. It is the nature of such an infection to spread faster and be most malignant where it is most resisted. To the Queen it is a more serious matter by far than rebellion in the Commons. Democracy has carried its work in that branch of the government beyond the hope of reversal long ago. So if the Queen's discipline is now to be mocked in the army, whither shall she go for somebody to rule? Her army parades are about all she has left of her glory, and with her soldiers in rebellion even this harmless occupation is gone.

But while the Queen trembles we do not observe any symptoms of alarm in other quarters. For royal parades a democratic soldier is worse than useless; he is a menacing burlesque and a nuisance generally. But for the defense of liberty and of country, if the country is his affair, he is the best kind of a soldler. He is the kind that won this great Republic from an English monarch, and has defended it through all its perils. In an army of ject of Eddy's handwriting.

education is no terror.

The idea that intelligence is essentially insubordinate is a fallacy. The discipline which makes its foe in arms tremble is that whereby physical manhood is fortified and controled by the best and noblest faculties of the mind. Such a soldier may not be much of a machine on parade, but when he shoots it is where it will do the most good. He feels that he is enlisted for business and not for foolery, and when his vocation is degraded by unessential and unbusinesslike servilities he is liable to mutiny.

In this country there is no punishment prescribed in the books for being manly; every son of America knows that, and it looks as though England would have to come round to the same habits of discipline. These repeated revolts against snobbish exactions may prove to be as useful to the progress of freedom as was the beheading of a

WHO WERE THE TRAITORS?

WE have proved by the returns of the election published in all the papers, that a considerable number of professing Republicans, while voting for former "Liberals" who were on the Republican ticket, scratched the "Mormon" names on that ticket and voted for the straight "Liberals."

A COWARDLY SLANDER.

THERE is nothing more mean and cowardly than the way in which the Salt Lake Tribune ghouls assail the dead. Governor Axtell would not succumb to the Tribune lash while he was the Executive of the Territory, so he was maligned and abused and secretly slandered by the Tribune gang, and when he was transferred to another Territory, their malevolence followed him to his new appointment. Now he is gone from this world and its injustice they talk of him in this way: "It is believed that for a moneyed consideration he sold out to the 'Mormon' Church." And on this surmise they make the final statement, as an excuse for slandering him in his grave, that "he in life betrayed his trust and vi lated his solemn oath." The statement is a ile, the rumor on which it is based was groundless fiction.

Governor Axtell simply tried to do what was at that time an impossible thing, namely, to reconcile the "Liberal" conspirators with the people against whom they were plotting.
