EASTERN

Power of Territorial Governors.

WASHINGTON, 25.—Upon the question submitted by Gov. McCook, as to whether, as Governor of Colorado, he possessed the power to remove or suspend territorial officers, the attorney general, acting attorney general Phillips has decided that the governor of a territory can remove only such officers as have been duly appointed by the Governor to hold office at his pleasure; and he is also powerless to remove officers appointed during pleasure by others, unless the organic law or, in some cases at least, the territorial law expressly authorizes him.

\$40,000 Fire.

NEW ORLEANS, 25.—A fire on Sixth Street, this afternoon, destroyed one of ten frame houses; loss \$40,000, insured \$25,000.

Damaged by Storm.

FORT WAYNE, Ind., 25.—Additional reports from the surrounding country indicate immense damage to property from the storm yesterday, which was the severest known in this section for many years.

Six Persons Killed by Lightning.

LOUISVILLE, 25.—A special says that a stroke of lightning in Woodford Co., last night, killed six persons in the same house.

\$40,000 Fire.

VICKSBURG, Miss., 25.—Rhumann's clothing house was burned to-day; loss \$40,000, insurance \$25,000.

CHICAGO, 25.—In a trot at Drexel Park, to-day, Goldsmith laid best Judson Fullerton in three straight heats, time, 2:29, 2:19, 2:25. Both horses broke, and Fullerton behaved very badly, and considerable dissatisfaction was displayed by the 7,000 or 8,000 people present.

Damage by a Water Spout—The Europe Disaster.

SAN FRANCISCO, 25.—A waterspout burst near Cannon City, Nev., this p.m., causing great destruction of property in five streets.

The loss by the flood in Eureka footed up to over one hundred thousand dollars. In addition to the names given this morning, the following were sent to-night, as drowned: Jas. Galvin, J. W. Talbot, J. Dorsey, John Raftis, W. J. McMurphy, and Wm. Smith.

A private dispatch which went from Eureka, states that fourteen dead bodies have been recovered.

Another report from Eureka says the storm was heavier to-day than yesterday, but the people were better prepared for it.

FOREIGN:

PRUSSIA.
Naval Orders—Germany in the Brussels Congress.

BERLIN, 25.—The North German Gazette says the German squadron, now off Rye, England, has been ordered to cruise on the northern coast of Spain, and that these orders were given in consequence of the shooting of Captain Schmidt, a German newspaper correspondent, and other German subjects, by the Carlists.

General Von Voigtschitz will represent Germany in the Brussels congress; he will be assisted by several distinguished officers and jurists.

FRANCE.

Organization of a Senate, &c.
PARIS, 25.—The committee of thirty have adopted, and the government has accepted the proposition of Paye Dupont, introduced in the Assembly on the 15th inst., for the creation of a senate, which provides that the senate shall consist of one hundred members, nominated by the President and 150 selected from, and by the Assembly, cardinals, marshals and admirals to be members ex officio; also that the president of the senate shall become provvisor of the president of the republic in the event of his incapacity, and that the president of the senate shall be empowered to dissolve the Assembly with the approval of the Senate.

The initiative have agreed to re-examine the bill, and Malleville's motion in favor of the dissolution of the Assembly be reconsidered; they have also examined a similar motion introduced by Duval. Their report on the above motion will be presented to the Assembly Monday next, and the question of dissolution will consequently be referred to the committee of prolongation, which was made the order for Tuesday. The Republicans are actively agitating for dissolution, and hope to have a majority on Monday, as many conservative deputies are absent.
