Abolish Oriental Schools and Admit Japanese Children to the White Ones.

> Washington, Feb. 8 .- Mayor Schmitz and the school board of San Francisco arrived in Washington at 5:35 o'clock this afternoon. Their train was 24 hours late. The delegation will be received by the president tomorrow Mayor Schmitz said:

"We have come to Washington with free minds to discuss the school question with the president. The more fact

tion with the president. The mere fact that we have responded to the presi-dent's invitation is sufficient evidence that we stand ready to make conces-sions if we are convinced that in so doing the entire country will profit by our action. No Californian is will-ing to stand on any technicality that will work to the detriment of the na-tion. It would be unfair for us to go into a full and free discussion of the questions involved until we have conferred with Mr. Roosevelt. "We have not excluded the Japanese children from the schools of San Francisco, but since the fire the school board has found it necessary to adopt the policy of segregation, not exclu-sion, in the primary and intermediate departments. The law of California makes the question of segregation dis-cretionary with the school boards in the various towns and cities of the state. The law reads that the school authorities 'may' segregate the chil-dren of the white and Mongolian races, and requires that when the sep-arate schools have been established the children of the two races must attend the schools set apart for them. After the fire we found that the Japthe children of the two races must attend the schools set apart for them. After the fire we found that the Jap-anese were crowding the white chil-dren out of the schools, and the only course to pursue was to take advant-age of the state law and establish the separate schools. This was done. The white children took the places of the Japanese in the white schools and the

white children took the places of the Japanese in the white schools and the oriental schools were established for the Japanese. That is the whole story in a nutshell." When asked as to how the Japan-ese children could now be admitted to the white schools if the delegation agree to make the concession which the president will ask, Mayor Schmitz rentied:

replied: "That would be simple enough. We would abolish the oriental schools, and then, under our law, the enforcement of which, as I explained, is left to the discretion of the school board, the Japanese would then be entitled to admission to the white schools."

Gen, del Costillo predicted an in-flux of American immigrants which, he declared, would result in the Ameri-canization of the rural guards and consequently military oppression of the Cubans. Throughout the entire meet

Cubans. Throughout the entire meeting a strong anti-American sentiment prevalled. Protest was made against imposing upon Cuba the burden of maintaining the proposed standing ar-my. A number of speakers contended that the fractious members of the ru-ral guard had been enlisted by the po-lice force.
