

SUIT AGAINST THE CITY

Mrs. Nellie B. Erickson Demands Damages in the Sum of \$20,000.

SHE FELL INTO A SEWER TRENCH

Case of the Hysteria Fugate Company as Defendant at St. Louis Court.

Nellie B. Erickson commenced proceedings against the City of Salt Lake City in the Third District court today by filing a \$20,000 damage suit. The complaint alleges that on the 15th of June, 1897, the city was engaged digging a sewer trench at a point near North and Fifth streets, when the plaintiff, who was at the time a child, fell into the trench. The trench was at least 10 feet deep and the plaintiff was injured, for which damages in the sum of \$20,000 are demanded.

HIG PORCELAIN SUIT.

Salt Lake and Ogden Gas and Electric Light Company Defendants.

Proceedings against the Salt Lake and Ogden Gas and Electric Light company of all have been commenced in the Federal court by the Farmers Loan and Trust company of New York, yesterday filed a suit to recover \$15,000 and interest on debt payable to the company on the 1st of January, 1901, and made payable January 1st, 1901.

The terms and conditions of the bonds provide that interest shall be paid semi-annually on the 1st of January and the 1st of July. The bonds were issued for a period of three months, the bondholders have the power to declare the whole of the principal due forthwith. Another provision is the establishment of a sinking fund for the redemption of the bonds. It is alleged that nothing has been paid into this fund and that the company has defaulted in the interest due on July 1st, 1901.

The bonds are secured by a mortgage on all the property of the company, real and personal, in Salt Lake and Ogden, and it is alleged that the company is insolvent and the mortgage property could not be sold to the advantage of the bondholders. The case of the Fifth & Farm company vs. E. A. Swenson, J. A. Swenson and S. J. Swenson, came on for hearing before Judge Chas. J. H. H. today. Action was brought against the defendants in January, 1897, to recover \$25,000 and interest on two promissory notes. The notes were executed at Denver, W. Colo., on the 10th of December, 1896, under the firm name and style of the Swenson Bros. & Co., and were payable to the order of the plaintiff. The notes were for \$12,500 each, and were secured by a mortgage on the land and improvements thereon. The plaintiff alleged that the defendants had failed to pay the notes, and that the plaintiff was entitled to recover the principal and interest thereon.

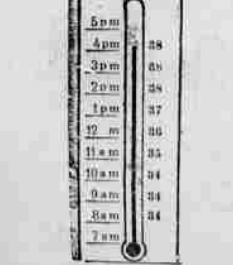
