

## VARIOUS PROBLEMS IN BALL GAMES.

Evolution of the Short Throw to Catch Runner Off the Base.

IT PREVENTS SCORING RUN.

Allows Runner to Reach Second but Generally Catches Man Off Third Base—How it is Done.

Of the various problems that are presented in the game of baseball, the evolution of the short throw to catch a runner off the base is one of the most complicated. A puzzling feature of this important point of the game and one that invariably causes comment among the spectators is the ease with which a runner generally achieves a steal of second base with a teammate on third and none out.

This play has resulted in the evolution of the short throw, one of the best of baseball tactics, and a play that has been developed to a high state of efficiency by some catchers. The idea of a runner stealing from first to second with a man on third is to draw a throw and allow the runner on third to score during the resolute attempt to retire.

The short throw, however, while it allows the runner to reach second safely, usually results as intended—in catching the runner at third in an attempt to score on the play. It is not a throw to be relayed to the pitcher.

The ball is jerked quickly to a point about ten feet short of second, to be met there by the shortstop, and as the man on third forms the conclusion that the ball was intended to go into play to catch the runner from first, he immediately starts for home, and a quick return by the shortstop catches him off the plate.

The advantage gained by shortening the throw is just what is required to get the ball back to the plate in time, and unlike the relay from catcher to pitcher and to second, is quick enough to take a throw and turn in time to get it to second to catch a runner from first.

On the other hand, any shortstop can take a short throw, providing he is looking for it, and the return to first of a throw to third involves no particular headwork. A third method of dealing with such a situation is the bluff by the catcher that he is going to throw to second, although the ball is not allowed to leave his hand in the swing around. At times this entices a runner to leave third base for the run home, but as a general thing he is not deceived and the base is stolen without effort.

With Jennings, manager of the Baltimore Eastern league team, and one of the most experienced ball players in the country, this gives his views on the advisability of allowing a runner to steal second with another on third and less than two out.

"With the runner on third and another on first when none or one is out and you are ahead on the score board, let the man steal second by all means. "With the score largely against you, and two out, you may as well ask nothing better than for a runner to steal down on our club under such conditions. I have given my men instructions in such cases to let the run in from third, but get the man going down sure. "The additional run gained will not amount to much if the chance to secure more is thrown away. If we are in that fix one run won't do us any good, but the chance to get more is valuable."

**RABBITS AND HUNTERS SHOT.**

The hunters who were wounded are from Leth.

There were 225 hunters in the party and the number of bunnies stated above were killed in about two hours. The weather was all that could be asked for and there were rabbits in plenty.
