Les Angeles, Cal., April 24.-Fines aggregăting more than \$12,000 have been paid în southern California for presecutions under the state pure food law since it became effective, according to an estimate made by State Senator Mc-Carthney, who introduced the bill in the legislature. This amount represents about 500 prosecutions against both manufacturers and distributors of edibles and confections, which were mislabeled or adulterated.
