Precipitation occurred over portions of Colorado, Utah, Oregon, Nebraska, Kansas, Missouri, Illinois, Oklahoma, Texas, Louisiana, Minnesota, South Dakota. It was snowing this morning over portions of Nebraska and raining along the north Pacific coast.

The temperature changes were unimportant except a fall of 10 degrees or more over portions of Utah, Idaho, Missouri and Texas; and a corresponding rise over portions of Arizona, Oregon, British Columbia and Manitoba.

The temperature was below zero over portions of Utah, Wyoming, Montana, North and South Dakota, Minnesota and Nebraska.

### TEXT WAS "JUDGE NOT."

Dr. Tanner and Apostle Cowley Address Students.

Dr. J. M. Tanner addressed the students of the Latter-day Saints' university this morning on the subject of school-day judgments. He asked, Are the estimates we form of our school-days likely to be accurate? The judgments of our school days are often faulty and unreliable.

A case was cited within the speaker's experience, showing that one man who is now able and prominent in this state was weak and obscure in school. Why this? Man is more than intellect. There are certain vital forces at work in every person that may not manifest themselves till comparatively late in life. Are you sure of your own future by reason simply of your present standing? No, go beyond of judging yourselves or others at this time. Especially be careful of passing judgment upon your fellow-students. Let the judgment of the schoolroom be important. It has to do with your friendships and your relations with one another. Therefore be generous in your sympathies and tolerant in your judgments. The more you can and do uplift others, the faster you yourself will grow. The higher your ratings for others, the more exalted will be your own souls.

Apostle Cowley said it was an inspiring sight to witness such a sight as was presented by the array of youthful faces before him. He remarked that Dr. Tanner had really made application of the Savior's injunction, "Judge not that ye be not judged." The young people represent the concentration of the labor, the wealth, the sacrifices of their parents, who have filed and waited in order to make possible this splendid opportunity for education that prevails among the young people of today. The lesson of appreciation ought to be well learned by those who attend such an institution as this. The parents of the young people that come here, ought not and surely will not be disappointed. It is not mainly those who are the most brilliant, but those who are most diligent and who are most devoted to principle, that make the lasting successes. Your education in this institution is, in its nature, symmetrical. It deals with spiritual as well as temporal things, and exemplifies the doctrine and words of our Lord and Savior.

Prof. Hinckley then showed the application of the remarks of Dr. Tanner and Apostle Cowley to the students in the various classes today. Some of whom he said, in a few years hence will be separated by a wide gap. Some will write their names high in the roll of honor, but some will fail, if we may judge the future by the past. The professor illustrated this proposition by citing several characters in early American history.
