

ALL PARTIES ENJOINED.

Peremptory Writ of Mandamus Issued in the Canal Company's Case.

NEW FINDINGS AND DECREE ORDAINED.

North River Irrigation Company Comes Out of V. V. of Settling at Jury.

(Case of Judge Cherry.)

The Supreme court handed down an opinion today in the case of the State of Utah vs. A. G. Norris, district judge, ordering that a peremptory writ of mandamus be issued to the North River Irrigation company, and that the plaintiff, the North River Irrigation company, be enjoined from interfering with the defendant, the State of Utah, in its right to use the water of the North River.

This case was an application for a peremptory writ of mandamus directed to Judge Norris commanding him to make and sign the findings of fact, conclusions of law and decree in the case of the State of Utah vs. the North River Irrigation company, and to enforce the same.

In March, 1897, the North River Irrigation company commenced action against the State of Utah, claiming that the State was interfering with its right to use the water of the North River.

The case was heard by Judge Norris, and he rendered a decree in favor of the State, ordering that the North River Irrigation company be enjoined from interfering with the State's right to use the water of the North River.
