

EMPEROR OF JAPAN TO THE PRESIDENT

Thanks Him for His "Disinterested
And Unremitting Efforts in In-
terest of Peace and Humanity"

IS SATISFIED WITH TREATY.

Cablegram Puts an End to the Rumors
That He Was Not Willing to
Signed Early.

Oyster Bay, Sept. 3.—President Roosevelt today received at 12:40 p. m. from the emperor of Japan warm thanks for his "disinterested and unremitting efforts in the interests of peace and humanity," and an expression of the Japanese emperor's "grateful appreciation of the distinguished part" the president has taken in the establishment of peace in the far east. The cablegram, which was received from the emperor personally follows:

"Tokio, Sept. 3.—The President—I have received with gratification your message of congratulations conveyed through our plenipotentiaries and thank you warmly for it. To your disinterested and unremitting efforts in the interests of peace and humanity I attach the high value which is their due and assure you of my grateful appreciation of the distinguished part you have taken in the establishment of peace based upon principles essential to the permanent welfare and tranquility of the far east. MUITSCHHO."

The cablegram from the Japanese emperor puts an end to the rumors that the emperor was dissatisfied with the terms finally concluded by his plenipotentiaries with those of the emperor of Russia. He records President Roosevelt full credit for the part he took in bringing about peace upon principles essential to the permanent welfare and tranquility of the far east.

The concluding sentence of the cablegram is especially significant. It evidently voices the belief of the Japanese emperor that the treaty about to be concluded at Portsmouth will be for a permanent peace.

It can be said that the president expressed no anxiety at the delay of the cablegram from the emperor of Japan. It was known here that the terms finally concluded at Portsmouth were dictated by the Japanese emperor himself and that they could not be otherwise than satisfactory to him and his advisers.

The delay in responding to the Japanese plenipotentiaries was due, it is suggested, to the desire of the emperor to be assured that the terms agreed upon would be incorporated into a treaty without the probability of a serious hitch.

That assurance, it is said, was conveyed to the Japanese emperor last night upon the practical conclusion of the draft of the treaty. The cablegram to President Roosevelt today followed in natural course.

Information reaching the president today from Portsmouth indicates that the treaty will be concluded formally and signed early this week, probably tomorrow or Tuesday. The substance of the treaty is being reduced to engrossed form, in two texts, English and French. As soon as the treaty shall have been completed the convention is important not only to the two belligerent powers, but to the civilized world, will be signed by the plenipotentiaries of the two governments directly in interest and will pass into history as the treaty of Portsmouth.

President Roosevelt passed the greater part of the day at Sagamore Hill. He and Mrs. Roosevelt, with some of their children, attended morning services at Christ Episcopal church. Notwithstanding the tremendous wind and rainstorm that swept over this part of Long Island, beginning early today and continuing until late this afternoon, the president and Mrs. Roosevelt sent the children home from church in a carriage and themselves walked the three miles to Sagamore Hill in the storm.

No official visitors were received during the day, although Representative Wadsworth of New York and Mrs. Wadsworth were house guests of the president and Mrs. Roosevelt. The president has announced that he will devote the remainder of his sojourn at Sagamore Hill to his usual routine of reading and that he will receive as few visitors as possible and will transact no business that is not of pressing importance. He has been greatly occupied this summer with public business, and has had scarcely any opportunity to enjoy his vacation. He will endeavor now to have some time to himself.

TREATY READY FOR SIGNATURE.

It Consists of a Preamble and
Seventeen Articles. More Than
First Expected.

DIFFERENCES AS TO WORDING.

Japanese Envoys Hope to Get Away
Tuesday; Russians That Day
Or Wednesday.

Portsmouth, Sept. 3.—From an official source the Associated Press is informed that the treaty is completed. It consists of a preamble and 17 articles, the substance of which has been given in the Associated Press dispatches. But there were still differences about the wording of the protocol at the last sitting, which must be signed before the treaty itself can be signed. The Japanese presented a protocol to which the Russians took exception. The differences, however, are expected to be straightened out before noon tomorrow, and it seems quite possible the treaty will be signed tomorrow afternoon.

The seventeenth and concluding article of the treaty provides that the exchange of ratifications shall occur within 30 days after its signature by the plenipotentiaries. The Russian ratification will be communicated to the Japanese government by the French minister at Tokio, and Mr. Meyer, the American ambassador at St. Petersburg, will communicate the Japanese ratification to the Russian government.

If the Russians are ready the treaty will be signed tomorrow afternoon at 5 o'clock, this date having been suggested by Baron Komura. Otherwise the treaty will be signed Tuesday morning. The plenipotentiaries have invited Gov. McLean to witness the signing of the treaty, and he has been telegraphed for. The Japanese hope to get away Tuesday, and the Russians Tuesday or Wednesday.

Mr. De Martens, who is extremely anxious to get back to Russia, has engaged passage on La Lorraine, sailing from New York Thursday, and leaves here on Wednesday.

ject by the Associated Press, remarked
laughingly:

"You are at liberty to announce, both
in Europe and in America, that we are
willing to make the treaty of Port-
