In Russia it is apprehended that the Easter holidays may be the occasion of them.

## PEOPLE ARE VERY PANICKY.

Caused by Rumors of Murder, Pillage and Terrorism by Mobs in Various Parts of Country.

## CZAR MAY PROCLAIM AMNESTY

For Political and Religious Prisoners Confined in Fortresses or Prisons or in Exile.

St. Petersburg, April 25.—A rumor is circulated here to the effect that Emperor Nicholas will mark Easter by the proclamation of general amnesty for political and religious prisoners now confined in the fortresses or prisons of European Russia or who are in exile.

Fears that the Easter holidays, which extend over 13 days, will be the occasion for bloody riots, are manifested everywhere and the population is becoming decidedly panicky over the rumors which are circulating of murder, pillage and terrorism on the part of the mob in various parts of the country. Even churches, according to the stories told, are not exempt. The people are being especially warned not to enter the St. Isaac or Kazan cathedrals or the church of the Uevsky monastery. The liberals pretend to believe that such stories are purposely circulated by the police. In any event the strain is becoming intense. This is holy week when all Russia is usually in sack cloth and ashes, but the poorer classes of the people who generally attend incessant masses now spend most of their time at the doors of the churches gossiping about what may happen next week. The solemn religious services at the Winter palace in ordinary years take place Saturday at midnight, with which Easter is ushered in and when the metropolitan of St. Petersburg proclaims to the emperor in the presence of the imperial family, ministers and reading functionaries the rising of Christ from the grave, will not take place this year on account of the danger involved. Instead a similar service will be held at Tsarskoe-Selo. Gov. Gen. Trepoff insists on his ability to preserve order and protect life and property. Among the persons arrested last night were three of the principal revolutionary leaders.

## DISORDERS IN POLAND.

Boleslaw, Russian Poland, April 25.—Great disorders are expected here at Easter time. The town is full of troops. Russian officials are receiving letters threatening them with massacre and the workmen have been deluged with proclamations signed by the Polish revolutionary committee. The police are endeavoring to keep the Jews but instead to kill all such persons. The proclamations are directed against the police, who are charged with attempting a diversion against the Jews.

## IS HE A SPY?

## A Russian Arrested on Island of Brani, Near Singapore.

Singapore, Straits Settlement, April 25.—A Russian, giving the name of Vladimir Antonovich, but carrying a passport made out in another name, has been arrested on the fortified island of Brani and was arraigned here today on the charge of being on government property without authority. He was remanded for a week. Antonovich, who does not speak English, was residing with a non-commissioned officer of the ordnance department. It is popularly supposed that Antonovich is a spy but the authorities say that no incriminating papers have been discovered.

The non-commissioned officer with whom Antonovich boarded also has been arrested and will be tried by court-martial for harboring the Russian. The latter claimed the Russian consul would furnish the \$400 bail demanded by the local magistrate, but the consul refused to do so.

Loubet spoke of the cardinal's spirit of tolerance, conciliation and patriotism. To the Jewish rabbi M. Loubet said: "You may be sure I shall always remember my duty and remain faithful to the principle of tolerance and respect all opinions, whether religious, political or philosophical, for these bind together our citizens and assure our country its proper place as a free republic."

## SCHWAB IN ST. PETERSBURG.

He is Making a Big Impression in the Russian Capital.

St. Petersburg, April 25.—Charles M. Schwab seems to be making a big impression here. His reputation as a steel expert preceded him and he is being shown much attention. Grand Duke Alexis has discussed with him for several hours matters relating to Russia's naval program which as tentatively elaborated by the technical committee, involves the expenditure of \$350,000,000 during the period of 10 years. Schwab has also conferred with Admiral Doussoff, head of the technical committee, and other prominent naval officers. The war has convinced Russia that she needs a vital one, and everywhere Mr. Schwab has encountered nothing but a firm intention to build up a navy to a size commensurate with Russia's aspirations for the future. In a general way it is believed that certain arrangements touching America's share in the construction, which must go to foreign yards, have been already agreed on in principle. The details, however, may require some time to work out. Mr. Schwab appears to be entirely satisfied with the result of his visit and negotiations, having made such rapid progress that he expects to be able to leave within a few days. It is considered a great compliment to the genius of America that the Russian naval authorities are inclined to consult Mr. Schwab's opinion.

## BETSY AND I ARE OUT.

Mrs. McLean Refuses to Recognize Mrs. Weed of the D. A. R.

Washington, April 25.—At a meeting of the national board of management of the Daughters of the American Revolution, Mrs. McLean, the newly elected president, has refused to recognize Mrs. Walter Weed of Washington, D. C., as the duly elected vice state regent for Montana. Mrs. McLean's grounds for refusing to recognize Mrs. Weed as a member of the board of management was that the election had not been certified by congress. Mrs. Draper, who managed Mrs. McLean's campaign, declared that she had letters from Montana proving that Mrs. Weed was not the choice of the majority of the chapters of the state for vice regent.

## PUNISHMENT BY SLICING

Abolished in China and Decapitation Substituted.

New York, April 25.—In response to a memorial of Wu Ting Fang, China's principal representative at Washington, an imperial edict just issued abolishes the punishment of slicing to death and substitutes immediate decapitation, cables the Peking correspondent of the Herald.

## HIS WALLET GONE.

W. E. Evans Loses Nearly \$3,000 on Northern Pacific Pullman.

Helena, Mont., April 25.—The porter or some other attaché of the Northern Pacific Pullman car that was en route from Helena to Spokane Saturday morning is believed to have found rich plunder under the pillow of a berth occupied by W. E. Evans, western representative of W. P. Willis & Co., of New York, in the shape of a pocket book containing \$2,717 in certificates of deposit on a Klamath bank and cash. Evans arrived here last night on his way to Butte and he admitted he did not miss it until he had his breakfast in a Spokane restaurant. He notified the railway company, but at last accounts the missing wallet had not been recovered.

## High Price for Wool.

Butte, Mont., April 25.—The high water mark for wool was reached last night when a Boston firm bought 150,000 pounds at Lewistown, at something above 21c. The buyer refused to divulge the exact figures.

## MONUMENT TO GAMBETTA.

One Unveiled at Bordeaux by Prest. Loubet.

Bordeaux, April 25.—President Loubet presided today at the ceremony of unveiling the monument of Gambetta by Daubigny. The statue stands in a dignified attitude on a pedestal. The figures about the pedestal include a child, a woman, a man, a soldier, a sailor, a peasant, a worker, a scholar, a patriot, a laborer at the close of the Franco-Prussian war. A vast crowd was present, and many notable addresses were made.
