SUDDEN DEATH
OF ELIJAH LARKIN

Old and Respected Citizen Succumbs to an Attack of Bright's Disease.

A. O. U. W. IS SUED FOR \$2,000

New Year Weddings—The Contest for Judgeship Will Be Heard Feb. 4—Judge Howell's First Case.

Ogden, Utah, Jan. 5.—Elijah Larkin, a former resident of Ogden, where he is remembered in very high esteem, and where he has three generations of descendants living; succumbed to a sudden illness yesterday morning at Ogden, in Tooele county. Mr. Larkin resided a few miles from Ogden, and the day before Christmas drove over from his home to that of his daughter, Mrs. Bates, to spend the Christmas holidays. On the way over he was seized with illness, which increased so that he had to be carried from the buggy to the house when he arrived at his destination. When a physician was called, it was found that he was suffering from an attack of Bright's disease, and from that malady he never recovered.

Mr. Larkin was 75 years old and was born at Cambridge, England. He came to Utah over 30 years ago and for a long period was aid-de-camp to President Brigham Young. For a number of years he was employed in Ogden as watchman for the Southern Pacific, discharging his duties with a faithfulness which earned for him the highest esteem of the officials of that system. He was first counselor to the Bishop of St. John's ward, Tooele county, and was an active worker in all church affairs.

He is survived by a widow, two sons and a daughter—W. Larkin, Joseph Larkin and Mrs. G. W. Bates. There are also about 30 grandchildren and 10 great-grandchildren.

Funeral services will be conducted at Salt Lake City on Sunday.

A. O. U. W. SUED FOR \$2,000.

An action was filed yesterday by Matilda Johanson against the grand lodge of the A. O. U. W., jurisdiction of Utah, Idaho, Wyoming, and against Mullin Johanson, claiming that her husband, George E. Johanson, took out a beneficiary certificate in her favor from Mullin lodge in May, 1933, and that he had the necessary requirements of the order to entitle his widow to receive the \$2,000, but that the lodge has refused to pay the claim.

NEW COUNTY GOVERNMENT

Big Rabbit Hunt by Utah and Juab County People.

Nephil, Juab Co., Utah, Jan. 3.—About 150 people came from Provo and other Utah county points to participate in the big rabbit hunt, that took place between here and Juab yesterday. About 200 joined our Provo friends from this city. The excursion train took 10 hunters within three miles of Juab, where they alighted and formed a line extending over two miles east and west, then they marched northward till they met the hunters from Nephil, who began their hunt just south of town. Just before the two sides met the excitement reached a high pitch, and the battery roared like a Japanese attack on Port Arthur. No one was hurt, but one young man was terribly frightened when the accidental discharge of a shell which shot his hat off his head. The hunters returned to town and enjoyed the hospitality of the Nephils. Two free dances were given, and the visitors expressed themselves as highly pleased with the outing. President Brigham of the B. Y. C. and some others of the faculty were present and participated in the hunt. About 1,100 rabbits were bagged.
