They repudiated the idea of being under any political or other obligation, and gave us the name of the person who, they are certain, conveyed the false information to the sheet that has libelled them.

That sheet says, "They are all children of polygamists." The statement is untrue, but that does not matter, except that an attempt is made to cast a cloud upon them. If it were a fact, it would not affect their citizenship or their legal status in any way, and they have just as hmue right to travel and change their abode as others. There are other errors, some of name and relationship, in the article which we stoop to notice, but they are all of a piece with the rest of it, and with the epithets and threats it contains.

Now, we will inform these young men, that if they, or anyof them, intend to make this city their permadent residence, they have a perfect right to do so and to exercise all the rights of residents and citizens in spite of the threats of "Liberals" or their organ.
