

THIEVE MUST HANG.

The Supreme Court so Decides at Its Sitting This Morning.

LEAK GETS THIRTEEN THOUSAND

for Injuries Received on the Rio Grande Western in Bligham Canyon—A Verdict of the Jury.

Thieves must hang.

That was the decision of the State Supreme court today. The mandate of the U. S. Supreme court was given, which affirmed the judgment of the district court, and on motion of Attorney Williams the case was removed to the Third district court for further action in accordance with law.

Leak Gets \$13,000.

The Supreme court handed down a decision today in the case of Frank Leak vs. the Rio Grande Western Railway company. Upon reading and filing the mandate of the Supreme court of the United States, wherein the judgment of the Supreme court of the Territory of Utah was affirmed, it was ordered that the district court should do justice to the plaintiff, with costs. The judgment obtained by the plaintiff was in the sum of \$13,000 for injuries received in Bligham canyon while in the employ of the defendant railway company.

Whereas court took.

A decision was also given in the case of D. H. Peery against Hester Wright, sheriff of Weber county. The court gave out of a sale of land, which was the subject of the suit, an order of sale in favor of the plaintiff.

Discharged Sergeant Reinstated.

The case was postponed because of the fact that the building was burned last fall some time under circumstances which resulted in the building of the defendant to this court.

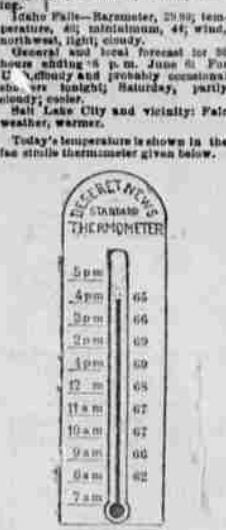
