# CLARA BAER BRINGS SUIT FOR SLANDER

She Says Sallie Young Accused Her of Strangling Her Baby to Death.

Clara Baer seeks to recover \$5,000 damages for slander in a suit filed this morning in the Third district court in which it is alleged that Sallie Young accused her of strangling her baby to death. The complaint states that on May 24, 1909, Sallie Young in the presence of others said so that she could hear it, "She strangled her baby to death," meaning the plaintiff. In the presence of Mrs. Baer's mother, the complaint alleges that Sallie Young said to her, "If I were you, I would not feel so proud after having strangled my baby to death." As a result of these remarks, Mrs. Baer declares that her reputation has been injured and her character ruined.

STIPULATION IS ENTERED.

Mrs. Mary A. Ross accepted \$2,400 for the death of her husband, George J. Ross, who was killed in an automobile accident by Dr. H. N. Mayo on Sept. 16, 1908, and dismissed her suit brought for \$25,000 against the physician in the Third district court. The compromise was effected yesterday by Judge Armstrong's court. Ross was killed in a collision between Dr. Mayo's automobile and a survey in which he was riding. The accident occurred at C and First avenue.

DONELLAN FOUND GUILTY.

Thompson, with a confederate it is said, entered the Gardner Clothing company store last Saturday, just after Frank L. Gardner had returned from the bank with three money bags. After Mr. Gardner had laid the bags on the desk, the confederate engaged his attention by asking to have changed into silver a quantity of currency of the denomination of \$1. While making the exchange Mr. Gardner saw Thompson pick up the bag of gold and start to leave the store. Mr. Gardner caught Thompson before the latter reached the door and after taking the money away from him, held him until the arrival of the officers.

MARSH ASKS MORE TIME.

Through an attorney James Marsh, the early morning assailant of Mrs. Fred Newell Tuesday, this morning asked until next Monday in which to enter his plea to the charge of assault with intent to murder. When arraigned yesterday morning Marsh took the statutory time in which to plead, his bonds being at first fixed at \$500 and later, upon the recommendation of County Attorney Job P. Lyon increased to \$2,500. Fred Newell arrived in Salt Lake yesterday afternoon and will take an active part in the prosecution of his wife's alleged assailant.

JOSEPH PLACED ON TRIAL.

Edward Joseph, a negro, is being tried this morning before a jury in Judge T. D. Lewis' court on the charge of assault with a deadly weapon. In the information he is charged with having stabbed Henry Weaver with a knife on June 26, 1909.

HEARING IS POSTPONED.

Marshall on the grounds that the petition was filed in the wrong district court, owing to the petitioners, J. J. Snider, A. H. Bohastengie, Alta Kelly and George M. Stratton failing to file an amended complaint in answer to the demurrer of the Salt Lake Public Service company made through its attorney Sept. 27, at which time the petitioners were given two days to answer.

DIVORCE IS GRANTED.

Mrs. Jessie Meles was granted a divorce this morning by Judge C. W. Morse from George Meles on the ground of cruelty. They were married at Cheyenne, Wyo., on June 4, 1907. Within a year after their marriage she testified that Meles began to treat her in a cruel and inhuman manner. On Oct. 15, 1908, he drove her out of the house and refused to live with her since that time. They have no children, but the court gave her \$50 a month alimony and \$50 attorney fees.

SUES CREDIT ASSOCIATION.

Edward Joseph, a negro, is being tried this morning before a jury in Judge T. D. Lewis' court on the charge of assault with a deadly weapon. In the information he is charged with having stabbed Henry Weaver with a knife on June 26, 1909.

HEARING IS POSTPONED.

After receiving a report from W. B. Albertson, receiver for the Salt Lake Public Service company, which has gone into bankruptcy, Judge C. W. Morse postponed the hearing to a later date and ordered Albertson to do what he could to keep the franchises granted by the city alive and not to let the applications for water rights in Little Cottonwood canyon lapse. A further hearing of the claims against the company will be called later.

PETITION IS DISMISSED.

The application for involuntary bankruptcy of the Salt Lake Public Service company was dismissed today by Judge John A. Marshall on the grounds that the petition was filed in the wrong district court, owing to the petitioners, J. J. Snider, A. H. Bohastengie, Alta Kelly and George M. Stratton failing to file an amended complaint in answer to the demurrer of the Salt Lake Public Service company made through its attorney Sept. 27, at which time the petitioners were given two days to answer.

DIVORCE IS GRANTED.

Mrs. Jessie Meles was granted a divorce this morning by Judge C. W. Morse from George Meles on the ground of cruelty. They were married at Cheyenne, Wyo., on June 4, 1907. Within a year after their marriage she testified that Meles began to treat her in a cruel and inhuman manner. On Oct. 15, 1908, he drove her out of the house and refused to live with her since that time. They have no children, but the court gave her \$50 a month alimony and \$50 attorney fees.

SUES CREDIT ASSOCIATION.

The Richfield Drug company of Richfield filed suit against the Utah Credit Men's association to recover \$5,000. It is alleged that the association seized the fixtures and stock of the company which is valued at the amount sued for.

DECREE IN FEDERAL COURT.

Judge John A. Marshall of the United States district court handed down a decree today in favor of the plaintiff in the case of the United States Mining company vs. Ed. E. A. Wall.
