

TRADESMEN CLASH AND GO TO COURT

Both Believed in Signs, But One
Felt Hurt Because of
Other's Methods.

LEVY MUST TAKE SIGN DOWN.

Interference With Business Shown and
Injunction Issues Which May Start
Yet Another Sensation.

Morris Levy, a clothier at 256 south State street, believes in signs and so does his rival, the Baron Clothing company, whose establishment is next door, at 254 south State street. But the signs and the business which Levy had painted yesterday afternoon in black letters on a yellow background interfered with the Baron company's business, and Judge C. W. Moore ordered him to remove the objectionable signs. "What's good for their business is good for my business," protested Levy, when the court made the order, but he afterward said that he would obey the command of the court. Levy was charged with violating the injunction of the Baron Clothing company in advertising a sale at "slaughtered prices." His signs were so arranged that they misled the bargain hunters into his store, which was marked as the "Main Entrance." He also had a sign which read, "Men's suits good enough for a duke or baron."

A Spielberg, manager of the Baron company, objected to the word "Baron," which made it appear from across the street that Levy's store was the same as the Baron company, and that Levy's door was the main entrance. Spielberg applied for an injunction, and after considerable testimony was heard the injunction was made permanent. The Baron Clothing company is conducting a "fire" sale and Levy is conducting a "no fire, no smoke" sale. Both Levy and Spielberg want this strictly understood, and they started out to see which could produce the biggest sensation in the advertising. Both stores are covered with signs and it finally resulted in Spielberg applying to the court who declared that Levy was interfering with Baron's business. Both firms presented testimony to show that they have been making preparations for months to open a big sale and it resulted in both companies throwing their doors open at the same hour this morning for the "big rush."

PLAN OF BOARD OF WORKS.

Effort to be Made to Land Paying Job
For Pat Moran.

In an effort to give P. J. Moran, the official contractor, the contract for paving east Third south street from State street to Tenth East street, the board of public works, which meets each Friday night, will require Pat Moran to show that they have enough equipment and backing to carry the extension through in record time. Strange & McGuire bid \$147,947.09 while Moran's bid was \$161,592.85. There were two other bids submitted to the board, one from the Barber Asphalt company and the other from the Bryant, Ford and McLaughlin Asphalt company, which were still higher than Moran's. This is the first competition which Moran has had in public improvements this year.

Two sewer contracts are to be let by the board Friday night. In each extension the James Kennedy Construction company was the lowest bidder. Extension No. 223 which is located in the southwestern part of the city will in all probability be let to the Kennedy company for \$161,822.99. The Kennedy construction company's bid on Extension No. 225 which is located on Center street and west to Second West street, was \$11,595.27.

SMITH WILL GO TO HOSPITAL

Sympathy Aroused for Man Neg-
lected by Police While Suf-
fering From Fall.

TIME TO REMEDY CONDITION

W. F. Jensen Starts Movement to Pro-
vide Fund for Care of Pen-
less Unfortunate.

Aroused by the brutal neglect of the police in allowing George Smith, a carpenter, to lie in agony in the emergency hospital, suffering from a seriously injured spine, two days and two nights, without proper medical treatment, W. F. Jensen, this morning sent Dr. A. N. Miner, at his own expense, to the emergency hospital to look into the case, and Dr. Miner pronounced Smith's condition so grave as to necessitate immediate removal to Holy Cross hospital.

Smith fell from the barn of the Jensen Creamery company, at Fourth South and Fourth West streets, while working on the roof in the capacity of a sub-contractor, Tuesday morning at 8 o'clock. He landed squarely on his back, after falling 15 feet. He was taken in the patrol wagon to the police station and placed on a narrow cot in the emergency hospital in the city prison. He laid there alone, without proper medical attention, until this morning, though he asked repeatedly to be sent to a hospital. His agonized cries aroused the sympathy of the "trustees" in the jail, who did what they could to help him, by rubbing his back with "saw-dust." Dr. F. R. Steele, the police surgeon, examined Smith and said that he ought to go to St. Mike's hospital, but on learning that Smith only had two days' pay, or \$6, coming, he went away.

Chief of Police Barlow and Lieut. Shannon were acquainted with the case, and knew that Smith was so sick and weak that he was unable to stand even with the assistance of two "trustees," but they made no effort to have the injured man sent to a hospital. Chief of Police Barlow did have a bed-pan purchased, and it was taken into Smith, but that was the only thing done for him.

W. S. Jensen stated today that he learned of the way Smith had been neglected by the police for the first time, Wednesday night. Mr. Jensen said that when Smith was hurt Tuesday morning, he supposed, of course, that he had been sent to a hospital, and was being properly cared for. But when he found out the true state of affairs, he immediately visited Smith, and told him that he would see that he was taken to a hospital and given medical treatment for his injured spine. Mr. Jensen said, further, that he was not responsible for Smith's neglect, but he determined to take it upon himself to see that the injured man received decent, humane treatment. He said that he would bear the expense at the hospital.

HIS EYES OPENED.

"This case has opened my eyes," said Mr. Jensen, "and I think that such a glaring evil in our city should be corrected. I never dreamed that Salt Lake City didn't have a city hospital for the care of the sick and injured who happen to be penniless. And, by the way, this causes me to enquire what the private hospitals here do with the money that is given to them by the charitable people of the city. I myself have been giving the hospitals \$100 a year. I can't understand why they shouldn't take such a case. Now, about two years ago, a man was badly hurt in front of my own house, and the city and no other person appeared to help him, I had him sent to a private hospital. What was my surprise, however, to receive a bill shortly afterwards for \$400. I paid the hospital the money. But this is merely a case in point, which I relate in order to illustrate the condition that exist here."

"I think that it is time for the humane people of Salt Lake City to end this shameful condition. I stand ready and willing to donate \$100 to a public fund for the building of a city hospital, where the sick and injured may be sent, even if they are without money or friends. They are just the people who need help from the charitable people. I hope that other men will respond, and contribute to such a fund."

It is understood that the Carpenters' union, of which Smith is a member, has also taken a hand in his case, and will see that he receives proper care from now on.

ANOTHER QUAKE.

Dr. Fred J. Pack, the University of Utah official who keeps his fingers constantly upon the pulse of Mother Earth, reports that at 4:12 Wednesday morning there was a slight pulsation of the crust which denoted an earthquake in the near vicinity. He says that the seismograph has recorded these tremors quite regularly for the past week, but that none of them was of particular moment.

LOSES DAMAGE SUIT.

James E. Christensen, who was permanently injured in an accident while employed by the Utah Gas & Coke company, lost his suit yesterday against the company when a jury in Judge Richter's court returned a verdict of no cause for action. Christensen sued for \$25,000 for the loss of his fingers on his left hand. The accident occurred on Feb. 19 last, when a car ran over his hand in the stock room.

NO FIRE TO PUT OUT.

Some person looked out of a window in the Tremont block, about 9:30 o'clock Wednesday afternoon, and saw what he thought was a great fire raging in the E. D. C. building. He called to the west patrol to be a false alarm, as the fireman quickly learned that the supposed fire was nothing more than a shadowing gas jet which leaked in a draft so that its reflections on the walls looked like a flame.

Estimable Woman Ends Long and
Notable Career and Leaves Sor-
rowing Friends Here.

Wednesday, in the death of Mrs. Elizabeth Vout Proctor, widow of Bishop John Proctor, at the age of 77, at her home, 428 Eighth East street, Tenth ward, where she had resided since the early days of this city. Mrs. Proctor has been falling for the last two years, but it was not until five days ago that she finally took to her bed from which she was not to rise.

Mrs. Proctor was born in Rockland, Norfolk, England, December 3, 1832, and was converted to Mormonism in 1845. She was first married to a Robert Long, but he died, leaving her with three small children. With them she emigrated to America, May 22, 1846, and, braving the hardships of the trail across the plains, reached Salt Lake safely the following October. Mrs. Long married Bishop Proctor, the second bishop of the church, in March, 1857, by whom she had four children. She leaves six children and 17 grandchildren, the children being Mrs. Adella Walsh of Farmington, Mrs. George Buckle, William J. Proctor, Adam V. Proctor, Mrs. Harriet Voth and Miss Annie Proctor, all of Salt Lake.

The deceased, especially in her early days, was one of the most active workers in the church, and in the settlement of Salt Lake. She was lovable as a mother, courageous as a wife, and was ever active among the wives and mothers who so heroically endured the toils and hardships incident to the early settlement of this city and valley. She lived to a ripe old age, ready for a higher sphere of action, and her kindly nature leaves many sympathetic and sorrowing friends. The funeral will be held Sunday at noon, from the Tenth ward meetinghouse.
