# STARTLES THEM

Minister From Murray Contends For Divine Healing.

SAYS IT IS BIBLE DOCTRINE

Fails to See Why it is Not as Effective Now as in thays of the Apostles.

Having for his subject "Divine Healing," Rev. A. G. Andrews of Murray yesterday delivered the following address at the meeting of the Sait Lake Ministerial society in the parlors of the Y. M. C. A.

This subject is not chosen because the speaker is anxious to do so, or that he esteems himself qualified to discuss it; but rather as a matter of enquiry, whether or not it is not a doctrine for today as well as for past ages. In the great plan of the ages, God saw that pure minds would need stirring up by way of remembrance, sometimes. This was frequently the case with Israel, and sometimes by methods very

Through the dark days of Romanism many Bible doctrines were lost sight of, buried in the rubbish of selfish schemes, substituted for the truth of God. Have we not been slow in getting back to apostolic simplicity of faith and doctrine, as well as prac-tice? One of the fundamental doctrines of the Apostolic church—the sec-ond coming of the Christ, was almost ignored, sadly neglected, at best. This doctrine has been the rallying cry of the Apostolic church, and was dec ared by an angel as the wondering disciples gazed up into heaven, desiring nore look at their departed Lord. this coming we are constantly urged to be ready; for this is the crowning or rejecting day. Notwithstanding these many admonitions the doctrine of the second coming was so neglected that it would seem that Satan took an opportunity to bruise the church, by leading one to take up this doctrine, and others to carry it to the other extreme.

This neglect of a New Testament doctrine has added two more sects to

the already overcrowded numbers. Now, are we as Christian ministers, responsible for the Dowjeites, and many other ites of like character, who are leading noble Christian brethren astray, astray as regards many Christian truths, simply because another doctrine has been neglected, the Bible doctrine of healing?

If "Divine Healing" is a doctrine of the Old Testament & New Testament, is it not a doctrine for the ages of the ages?

I. Is "Divine Healing" a Bible doc-Let us examine a few passages. Exodus 22;25;—"Ye shall serve the Lord thy God. . . And I will take sickness from the midst of thee." Ex. 15:26—"If thou will diligently hearken to the voice of the Lord thy God, and will do that which is right in his sight, I will put none of these diseases upon thee, which I have brought upon the Egyptians; for I am the Lord that healeth thee." Ex. 23:26-"Ye shall serve the Lord your God. . . . And I will take sickness away from the midst of thee.'

away from thee all sickness." I Kings 8-We remember Solomon's prayer for Israel's restoration from sickness when they should look toward heaven was promised that this should be beard 103:3-"Who forgiveth all thine iniquities; who healeth all thy diseases." These passages are very clear promises of healing, and that they were fulfilled when the conditions were compried with, none but skeptics will deny

Deut. 7:15-"And the Lord will

As early as in the days of Abraham (Gen. 20: 17) "Abraham prayed unto God, and God healed Abimelech and his wife, and his maid-servants." Hezekiah, and even Naaman, a heathen, were healed of incurable dis-eases; and others were raised to life from the dead. We love to think of that simple faith which led Israel to

look and live when thousands were dying from the serpent's bite. These cures were multiplied just according to their faith and obedience It was the fulfillment of the divine law 'According to your faith be it unto

All of these and many more are a All of these and many more are a part of the Old Testament history. We are told also that "God is the same, yesterday, today and forever." 'In him there is no variableness or shadow of turning."

Did He intend that these wondrous healings should continue in the new disparents of the same and the same are the same and the same are the same ar dispensation? All except the skeptic continue through the Apostolic age. We

need any recital of proof.

Just here is where the diversity of opinion comes in. While all are of one nind that, for spiritual healing hand is still stretched out to heal th coul, it is withheld as regards the body The unchangable God has changed, and the power once so powerful to heal the body has now become inoperative, if not impotent.

To give any solution to this strange problem, or intelligent reason for a change, the writer has heard none save this: "That healings are obsolete they do not take place, they are something of the past.

No one ought to have more charity for those who take this view than the writer himself. He was taught from infancy that this blessing of the Church had been withdrawn, and that it was no longer needed to confirm the Saints or convince the world. Therefore, he looked no further than his own ho to learn, if possible, things continued or not. ## LOW RATES TO WEST CONTINUE

Big Passenger Traffic of Summer To Exist Through Winter.

SALT LAKE WILL BENEFIT.

Excursionists From the East Arc Bound to Visit Her Bi Attractions.

Passenger trante to and through Itali during the past summer been of such proportions to produce the impression that an end must soon come to the stream of traveling humanity that has been coming this way. Such is not to be the case, however. There are, in the main, three facts which have contributed toward sending so many people out to this western country. The first is man's natural curiosity and desire to see new places and fresh scenes; the second, the presentation of an opportunity to do this, in the exceptionally low rates given by western roads, by visiting this part of Uncle Sam's domain; and the third, the possession by Utah of such charming attractions as to make her the Mecca of wayfarers from the eastern and middle States. Now comes an anouncement from Chicago, by the Associated Press, that to a large extent the low passenger rates that have been in effect in the territory west of Chicago during the summer, are to prevail throughout the winter months. Independent action has taken by a number of western roads providing for excursions on the first and third Tuesdays in October, No. vember and December to Colorado Utah, Wyoming, Idaho, Montana, Ore-

gen, Washington, Manitoba, Canadian Northwest and British Columbia. That means, of course, that with due llowance for the objection of some ple to traveling in the winter time pussenger truffic in this direction is remain practically undiminished While many of the excursionists may have for their objective point states west and northwest of Utah, most of them will pass through this State; and if they do these people will not omit Salt Lake from their itinerary. If the low rates referred to remain in vogue dur ing this winter, their renewal for nex summer will follow as a matter of course, unless something unforeseer happens to send passenger rates up to an impossible figure for excursionists Just now Salt Lake and Utah are ro ceiving much effective advertising and railroads are to be thanked for

Philadelphia, Sept. 23,-The Enquirer will say tomorrow:
"A. J. Cassatt, president of the Pennsylvania Railroad company, has demanded of George Gould the surrender of the Wabash system and the Wheel ing & Lake Erle at a price which will net a profit to the Goulds, under threat of cutting off the whole of the Western Union Telegraph lines from the entire Pennsylvania railroad system, as well as from the Vanderbilt lines, which

have agreed to the deal. "This is a threat that means a war greater than any that has ever taken place in this country, and is compara-ble only with that of the Beech Creek & South Penn. in 1885, which resulted in the abandonment of these lines except as built, which were swallowed up by

the Vanderbilts and the Pennsyl "The penalty means that the Western Union will suffer the greatest blow in its history, and will lose many of its profitable lines, which will be turned over to its great rival, the Postal Tele

This ultimatum means more than any other rallway deal in the history of the country.
