Received and filed, and invitation accepted with thanks.

## ADDITIONAL HELP.

The city engineer reported that he employed additional assistance for his office and asked confirmation by the Council of the same. Adopted.

# THEY MUST PAY FOR IT.

The same officer reported that he did not think that the granting of the petition of Abraham Lewis and others asking that Third West Street be-tween Ninth and Tenth South Streets be opened was of such advantage as to go to any expense in the matter, but recommended if the petitioners were willing to do the work at their own expense, that the petition be granted. Adopted.

#### TO PAVE CITY CREEK.

The city engineer reported that the cost of paving City Creek, between Fourth and Sixth West streets, would be about \$3.25 per linear foot, or \$2310 per block. He says: "In view of the fact that the stone work would require to be constructed on a foundation of loose material hauled in, I recommend that a lumber flume costing about \$2 per linear foot be employed instead, if the improvement is ordered. A bridge at Fifth West street will cost about \$100. Received and filed.

The committee on sewerage reported favorably on the enlargement of the LAWSON AND SEWERAGE.

#### ATTORNEY'S REPORT.

Assistant City Attorney Eichnor reported as follows: That the petition of Auerbach Bros. be referred to the board of public works; that in the case of William Lowe vs. Salt Lake City wherein the plaintiff claims \$5,000 damages, he had filed a demurrer to the complaint on the 12th inst., which temporarily disposed of the matter.

The committee on fire department reported favorably on the petition of Chief Stanton for the purchase of 3,000; additional feet of hose. Adopted,

### ENDORSE TRIMMER.

The committee on streets endorsed the suggestion of Fred Trimmer that lamps he placed on electric feed wires whenever fearible. Adopted.

### IN TWO DAILY PAPERS.

The committe on streets recommended that the city attorney prepare and the city recorder publish (for ten days in two daily papers) a notice calling upon owners of subdivisions to remove fences and other obstructions from the public streets. Adopted.

## THE AID SOCIETY'S PETITION.

The Young Ladies' Aid Society was granted the privilege of erecting and maintaining refreshment in Liberty Park for the summer of the present year.

# PRISON LABOR AGAIN.

The committee on prison represented that it was desirable to put the city prisoners at work as soon as possible, and that the matter of making suitable and that the matter of making suitable arrangements with the railroad companies for ground on which to work. The committee suggested that the ground immediately west of the City Hall he used for the purpose of furnishing employment for the city presence for the present. Rock could prisoners for the present. Rock could be hauled there and prepared for mac-adamizing purposes. The committee asked that it he authorized to pur-chase tools for that purpose and that in the meantime the city marshal be directed to employ the city prisoners as he deems best. Adopted.
