

ALL IS QUIET IN COAL CAMPS.

Strikers Took Their Eviction Papers Yesterday Without a Word of Back Talk.

DEMOLLI IS STILL IN JAIL.

Habeas Corpus Writ Was Denied at Price—If Italian Organizer Is Released He Will Be Re-Arrested.

There was no outbreak yesterday, by strikers in the coal regions. Notices of eviction were served in the Scofield, Winter Quarters and Clear Creek mining camps, on the men who refused to go to work, and the writs were received without disorder. The papers were served by deputy sheriffs attended with armed guards, and the troops were ready "within striking distance." But there was no resistance or threats of violence by the evicted.

The call for a general strike has been postponed for a few days until Con. Kelleher arrives, when a call will be made for all miners favorable to organized labor, to walk out. There has been no marked gain by either side in the last two days. Atty-Gen. Breiden is at Scofield to investigate on his own account. He interviewed Justice Burrows who gave Demolli 30 days, and finds that the proceedings were regular. The woman figuring as "Mother Jones," is not the woman of that name who was prominent in the Pennsylvania strike. The similarity of names and affiliations led to "mixing the babies up."

Signor Demolli continues "playing in hard luck." He was before Judge Johnson yesterday at Price on habeas corpus proceedings, and was represented by Messrs. Edler and Fowler and Atty. Crawford of this city. The state was represented by Atty-Gen. Breiden. The court found no grounds for the issuance of the writ as prayed for, and dismissed the petition, remarking that the petitioner had not gone to work the right way. Later, petitioner gave notice of an appeal, which was approved by County Atty. Frye, and Justice Burrows at Scofield was notified to make an order discharging the prisoner. But Demolli had not been discharged last night, and as Sheriff Wilcox has two more warrants for the Italian's arrest, it is evident that the latter is destined to have a strenuous time of it before the law is through with him.

County Attorney Frye is at Sunnyside today, to dispose of several breaches of the peace. Two fines were brought over to Price yesterday afternoon, to serve 15 days each for violations of the peace. This makes seven of the strikers in the Carbon county jail.

Six hundred tons of coke came out of Sunnyside yesterday afternoon in 15 cars. Seven of them are consigned to Birmingham and eight of them to the Murray smelters. About 25 additional miners from Emery county went to work in the mines yesterday. The increased number of cars coming out of Sunnyside shows that additions are being made to the working force there. Everything has been orderly for several days at Sunnyside. Many Italians and Austrians are leaving both Sunnyside and Castle Gate, a great number going home to their native land. The coming 10 days is expected to see quite an exodus from both camps. More Italians are returning to the fatherland than Austrians. The union workers are not making any headway with the men from Emery county being brought in.

Lieut.-Col. Greenwald of the First Infantry and Lieut.-Col. Lund of the brigade staff have leaves of absence for one week from "the seat of war."

Two sentinels of H company fired on an unknown man Sunday night, who refused to halt when called on, and he escaped. It was believed afterwards that he was a homeless striker endeavoring to find shelter in a box car.

Members of F company of Manti feel more or less elated from the fact that all of the orderlies have been selected up to date, from that company.

Sergeants Kenyon and Thomas surprised their fellow soldiers yesterday, by the former's shooting with his revolver a glass bottle from Thomas' head. But it afterwards developed that the pistol fired a blank cartridge, and the bottle was a "property" bottle specially prepared for such stunts.

The soldiers are killing time with mandolins and banjos and talking machines, as well as in good singing.

Sergeant Kemmer of F company served 18 months as a runner with battery A Utah Light Artillery in the Philippines, and did good execution with his Hotchkiss.

The soldier who reported that he had found a bath tub in Scofield is threatened with court-martial.

Treble Director J. C. Stubbs of the Harriman roads is expected to arrive in Salt Lake this afternoon to settle the uncertainty as to the wholesale prices of Wyoming coals, which is not known whether there is to be a reduction on freight or the price of coal, and Mr. Stubbs will have to decide this.





Hardly proposed an amendment to the police department ordinance providing for the employment of two assistant jailers, instead of one. The amendment was lost. Black attempted to have the number of patrolmen increased from 35 to 40, so that the additional five men could patrol the residence portions of the city, one in each precinct. This amendment was also lost. Black then attempted to arrange it so that five of the 35 men would be appointed to patrol the residence portions, but his second effort was also unsuccessful.

When the coal license ordinance was being considered Black offered an amendment providing that the license be fixed according to the price per ton of coal. It provided that when coal is sold for less than \$4.50 per ton the license shall be free; when \$5 per ton the license shall be \$200 per year, the same as at present; when from \$5 to \$5.50, \$720; from \$5.50 to \$6.30, \$900; from \$6.30 to \$7.05, \$1,200; from \$7.05 to \$8.05, \$2,000 per annum. The amendment was lost, however, and the license will remain the same as at present.

In the description of the boundaries of the various precincts the name "Main" street was changed to East Temple street wherever it occurred.

ROUTINE MATTERS.

The Ladies' Literary club submitted a resolution, adopted at the last meeting of the home and education section of the club, requesting the city council to provide a covered patrol wagon as it is greatly needed for "obvious reasons." The matter was referred to the police and prison committee.

City Recorder Nyström, ex-officio clerk of the city court, reported that there were 255 cases disposed of in the criminal division of the court during the month for which \$1,856 was received in fines and forfeitures.

City Auditor Reiser submitted the department payrolls for the last half of November amounting to \$8,022.92 which were referred to the finance committee with power to act.
