



CONFERENCE IN LOS ANGELES

Crowded Meetings Necessitate a Larger Meeting House.

Elder Geo. E. Fowler writes from Los Angeles, Cal., Dec. 5, as follows:

The Los Angeles conference was held Dec. 4, 1904, at the beautifully located Los Angeles Tabernacle, 16 West Twenty-eighth Street. Elder Geo. E. Fowler, president of the conference, presiding.

The conference was the most successful ever held here, the meeting-house being crowded to the doors at all three sessions, 10 a. m., 2 and 7:30 p. m. From the rapid growth of the work in this land it is evident that the Church should have a larger and more commodious tabernacle of its own.

At the morning service, President Jos. E. Robinson of the California mission, opened the conference with an address of welcome to our friends and encouragement to the Saints. Elders A. R. Weston, S. E. Brimhall of San Bernardino, C. M. Egan and C. F. Burton of San Diego were the speakers, dwelling principally upon the first principles of the Gospel.

In the afternoon Elder J. Geo. Barnes of the Los Angeles branch made a short address on church organization. President Robinson then presented for adoption or rejection the names of the general authorities of the Church, also the mission authorities; all being unanimously accepted. Elder Chas. W. Hill and President Geo. E. Fowler occupied the rest of the afternoon session, on the subjects of Deity and the Book of Mormon.

Elder G. W. Hogan at the opening of the evening meeting addressed the assembly a few moments, and the remainder of the evening was occupied in a very able manner by President Robinson, who spoke for over an hour on the beauties of the Gospel restored to the Prophet Joseph Smith, showing how it is changing and is unaffected by the various creeds of the various sects of Christians since 1830.

During the services Miss Minnie Gallagher of Salt Lake and Miss Alpha Lund of Los Angeles sang several solos each, and a quartet was rendered under the direction of A. R. Weston, composed by himself. Chas. W. Hill, Alpha Lund and Lizzie Anderson rendered sweet music in abundance.

Monday, Dec. 5, at 10 a. m., President Robinson convened a priesthood meeting. All the Elders gave reports of their labors during the past half year. Timely instructions were given by the president, and the Elders were assigned as follows: Elder John G. Watt as president of the Los Angeles conference, with Elders A. R. Weston, S. E. Brimhall, Wilford Noyes, J. W. Egan and C. R. Remond to labor in Los Angeles. Elder Geo. W. Hogan, N. P. Thompson, J. W. Rhodhouse and J. Geo. Barnes at San Diego, and Elders C. F. Burton and O. W. Badger at San Bernardino.

Elders Geo. E. Fowler, Chas. W. Hill and C. M. Egan were released to return to their homes at their pleasure.

East Pennsylvania Conference.
