The Power and the Glory.
Rome, Sept. 28.—There has been a new and active disagreement between King Humbert and his Vicars. The Pope, however, to represent the King's right to nominate parish priests for Neapolitan parishes, has prohibited the King from naming any more than one priest to each parish. The King has issued a decree to prevent any further nominations.
