SENATE.

WASHINGTON, 21.—Bayard, from

the finance committee, reported a

substitute for the McPherson resolu-

tion on the tobacco tax, which pro-

vides for rebate on stocks on hand.

He will ask that the resolution be

considered to-morrow.

Saunders offered a resolution that

the sense of the Senate was pre-

emption which allows land entered

on purchase at \$1.25 per acre with-

out requiring permanent settlement

should be repealed, and hereafter all

government lands be held for actual

settlement, referred.

revenue bill. This bill pro-

posed a system of competitive ex-

aminations for lower offices, a sort

of sausage stuffer through which

each man must pass before he could

get in general string. (Laughter.)

There was a great deal of honest

talk about civil service reform.

Real reform would consist in put-

ting decent and honest men in high

places, and letting them bring back to

the glory of the republic to the

principles and practices of the ear-

lier and better days. He would like

to see the democratic membership of

Congress who could go back to his

constituents and tell he had voted

to make the tenure of the present

officers permanent in order to

keep his friends from being tem-

pered into office-seeking. (Laughter.)

How many votes would that man

get? Why, he would be hoisted.

The people think and I think

whoever party is in power has the

right to put its friends in office. As

for this poor little thing before us,

I don't think it is worth a vote.

Little while we come on, and I don't
