First Section of Concentrator Will Soon be in Action At Lark.

EMPLOYMENT FOR 150 MEN.

One Taken Out in Development Work Will be Treated at Start—Will Handle 500 Tons Daily.

By the last of this week the machinery of the Ohio Copper company mill at Lark will be in position for the treatment of ore that has accumulated in developing this large property.

The opening of the mill means the employment of about 150 men and will add considerable life to mining in Blinnham.

General Manager John McCulloch visited the property yesterday and looked after the final details of arranging the mill for action.

All plans for the plant have been made with the view of doubling the capacity as soon as the entire mill has been started up.

Produce New Device for the Treatment in Place of Stamp Mill.

IS NOW WORKING ON ORES.

Ball Dog Mine Near Goldfield, Arizona, Experimenting on Its Product With New Machine.

Every day for the treatment of ore and among the latest is that of Julius Johnson of Mesa, Arizona.

THE NEW MACHINE DIFFERS RADICALLY

in principle from the prevailing stamp mill, the grinding forces being the centrifugal force imparted to the ore by the revolution of the cylinder.

THE NEW MACHINE IS BEING BRIEFLY DESCRIBED AS FOLLOWS:

A small drum filled with concrete or some solid material to prevent its being crushed by the impact of the heavy ore is placed on a horizontal bearing.

GEARED TO ENGINE.

Motion is imparted to the outer drum by the friction of the smaller drum which is geared directly to the engine.

SMALL POWER NEEDED.

It is estimated that the new contrivance, working in capacity of a 100-stamp mill, can be operated by a 20-horse power gasoline engine.
