His death followed an administration of ether by Dr. Charles McBurney and the family doctor, Dr. McLean, who were about to make an examination to ascertain if the colonel's suspicions that he suffered from a stone in the bladder were correct.

Last evening he merely told Manager A. H. De Freese that he would probably not be down on Friday but he would be there Saturday afternoon. Before the arrival of the doctor he complained of severe pains and called on the *Mail and Express* and gave a number of instructions about the future conduct of the newspaper in case anything should happen to him. Later the distress he suffered led him and when the physician detected dangerous symptoms and stopped the tubular catheter. Colonel Shepard sank rapidly and for some time it was feared he could not be rallied. Powerful restoratives were administered and at the end of an hour's work with oxygen he was restored to partial consciousness, and continued apparently to rally until 4 o'clock. Then without warning and for no apparent reason he began rapidly to sink. The oxygen treatment was resumed, but it was of no avail. At 4:20 o'clock he died. He was unconscious and his death was peaceful.

The cause of the death, as given by the physician, was as follows: Colonel Shepard's death occurred while he was lying on his back, and he was very low and might not live. His death occurred at 4 o'clock. Immediate friends of the family soon began to arrive, and a string of carriages was continually at the Fifth Avenue side of the residence. A late hour no arrangements had been made for the funeral.
