

## GOOD BALANCE TO START WITH.

Handsome Sum of \$1,135,562.10  
Turned Over to City Treasurer Swenson.

### CITY AUDITOR MAKES REPORT

Over Three-Fourths of Special Water  
And Sewer Fund Not Yet  
Contracted For.

According to the final report of former City Treasurer Fisher Harris there was a cash balance turned over to the present city treasurer on Jan. 2 amounting to the sum of \$1,135,562.10 so that the new administration had a very substantial balance on hand with which to start on its career. This balance includes the water and sewer bond money not yet expended on those special improvements. Following is a segregation of the total balance:

### AMOUNT OF CONTRACTS.

It will be seen that the amount in the water and sewer bond fund was \$850,000. According to the report of former City Auditor Felt the amount already spent on the special water proposition was \$170,332.36 and the additional amount contracted for is \$199,682.44 leaving a balance unexpended and not contracted for in the \$850,000 water bond fund amounting to \$470,985.20. The amount contracted for out of the special sewer bond fund is \$182,765.00. This exceeds the amount originally intended to be spent on the special sewer improvements but the idea is to meet the additional expenditure out of the general sewer fund.

### WANTED FOR FORGERY.

Gov. Cutler Issues Requisition for Return of W. M. Perrill.

Gov. Cutler yesterday issued requisition papers upon Gov. Pardee of California for the return to this state of W. M. Perrill, who was arrested at Los Angeles recently, and is wanted in Provo upon the charge of forgery. The complaint charges that, on Oct. 23, 1905, Perrill forged the name of William Adams to a check for \$66.35, drawn on the Market National bank of Cincinnati and cashed the same at the State Bank of Provo. County Attorney Anderson of Utah county secured the requisition papers yesterday, and Sheriff Harris left with them last night to bring the man back for trial.
