

YOU ARE HEREBY required to appear

in an action brought against you by the People of the United States in the Court of the Third Judicial District of the Territory of Utah, and to answer the same, and to file your answer within ten days (exclusive of the day of service) after the service on you of this summons, and to file your answer within twenty days (exclusive of the day of service) if you served out of this country but within the District, within twenty days, otherwise within thirty days, failing which process will be taken against you, according to the prayer of said complaint.

Process will be issued to recover from you the sum of \$500, with legal interest thereon, from April 1st, 1875, alleged to have been due to the United States, or to be recovered by you from plaintiff April 1st, 1875,

and to obtain an order of this Court for

a foreclosure of a lien of plaintiff's re-

quested certificate of deposit given by

the said Neal & Fisher, and delivered by you to plaintiff as collateral security

for the payment of plaintiff's claim for

plaintiff, and for cost of suit.

And you are hereby notified that if you

fail to appear, the said plaintiff will sue to the Court for the relief de-
