Supreme Court, Decree a Division of Costs in a Mining Case.

Next Back to the Trial Court

With Instructions—The Mining Suit in Judge Street Court—Against Plaintiff.

The Supreme court handed down an opinion today in the case of the Western Mining company, respondents, vs. Francis P. Jennings and others, appellants. The record in the case shows that the plaintiff was the owner of a mine consisting of the Walker and Walker Extension and Rusty mining claims, and a part of the Placer claim, and that they were sold to the defendant, who was then the owner of the same. The plaintiff then brought an action against the defendant to recover the value of the mine, and the defendant answered by denying the plaintiff's claim, and setting up a counterclaim for the value of the mine.
