## CHRISTENSEN ON TRIAL FOR ARSON.

E. T. Woolley Wins Suit for Salary Against Ogden Woolen Mills Company.

## PICTURE GIVEN STATE SCHOOL.

The preliminary hearing of Neichristensen, known also as Erdahl, on a charge of arson, was had yesterday afternoon in the city court before Justice Howell. Mrs. Crow, with whom Christensen was living, gave rather damaging testimony against him. She returned from Ogden to the house where they were occupying, in North Ogden, about 4 o'clock in the afternoon, and noticed the smell of coal oil in the house. She spoke of it, but was warned by the man never to mention it. She also testified that the man took most of the pictures off the wall and one of the carpets off the floor. That night she was awakened by him telling her that the house was on fire. By the time she got out the building was all in flames. Christensen made application for the collection of \$300 insurance on his furniture. The woman said most of the furniture belonged to her and that there was no insurance on it. Judge Howell took the matter under advisement until this morning at 10 o'clock.

## WOOLEN MILLS LOSES SUIT.

In the district court yesterday Judge Blagden rendered a decision in the case of E. T. Woolley against the Ogden Woolen Mills company, awarding plaintiff judgment for \$708, claimed as salary while acting as the company's manager under contract. T. mills burned down and the company attempted to abrogate the contract. Woolley sued for salary during the time the contract was supposed to be in force. Judge Blagden yesterday again postponed the sentencing of Christian Peterson. Peterson is the man who robbed John Coffin in the head at Davisville a little over a year ago and who entered a plea of guilty to assault with a deadly weapon. He is at present out on bond.

Ellen Wright Jackson was born June 30, 1835, in Comorom, Hertz, England, and died in American Fork Dec. 11, 1904. She was baptized in December, 1849. About this time her father was given the choice by his employers of leaving the Church or losing his position. He chose the latter, and emigrated as far as St. Louis with a portion of his family, and was joined by the remaining part shortly after. Sister Jackson arrived in Utah in September, 1852, having been married with many others walked nearly 1,000 miles

## HENRY TEEPLES DEAD.

Indefatigable Pioneer and Home Builder Goes to Well Earned Rest.

LaBelle, Fremont County, Idaho, Dec. 7.—On the 2nd inst. Elder Henry Teeple, an early pioneer of Utah, died in Ogden, where he had gone to undergo surgical operations for a number of years. He was 85 years of age. The remains were brought to LaBelle, Idaho, where deceased last resided. On the 6th inst. funeral services were held and the remains were laid to rest. A very large crowd of relatives and friends gathered to pay respect to the deceased.

Elder Teeple was 65 years old at his death. He leaves a wife, 14 children and a host of friends to honor his memory. He was an early settler in Utah, came across the plains with the pioneers and reached Utah in 1848. Though but seven years old, he drove an ox team most of the way. He assisted his father in building up a number of homes in Utah. One in Salt Lake, Provo and Goshen. When 22 years old he moved to Holden, Millard county, where he resided for 24 years. When 46 years old he moved to Burville, Sevier county, where he was Bishop for 14 years, laboring faithfully for the interest and good of his people and for the beauty and growth of his ward. He was a man that was true to his family, true to his friends and true to his God. His door was always open to the poor, his means were given freely to all public enterprises. Four years ago he arrived in LaBelle, Idaho, and his influence has been a power for good to all, never tiring in his efforts to build the country. He was honored and loved by all who knew him.
