Sunday Services.

Religious services were held at the Tabernacle, Salt Lake City, Sunday, June Sth, 1890, commencing at 2 p. m., President Elias Morris presiding.

ELDER JACOB GATES

was called to address the congregation. He said the principles God has revealed for the benefit of mankind should be sought after, because all men had an interest there-in. They should seek to receive the Holy Spirit, to be guided into all truth. Paul says that the Gospel is the power of God unto salvation. Faith is its foundation, for without this it is impossible to please God. Faith is inspired by hearing the word of God, taught by those authorized by the powers of heaven. If we can re-ceive and exercise faith, it brings us knowledge and opens the door to salvation. The people, on the day of Pentecost, inquired of Peter what they should do. They had mani-fested faith, and were instructed to repent and be baptized. Upon doing this they were to receive the Holy Ghost; and this promise was to all whom Goishould call. In the absence of this Spirit no man can find out God. This Spirit should lead them to all truth; it should take them forward, step by step, and should bear record of the Father and the Son, whom to know is life eternal. This promise is within the reach of all who will receive the light.

This Holy Ghost is received through a form and an ordinancethe laying on of the hands of a man of God authorized for the purpose. It may seem strange to some to speak of a man being thus speak of a man being thus authorized, but it was just such men who bestowed it anciently, and none others. Today this gift is bestowed by men who are authorized of God to establish His work in this the dispensation of the fulness of times. When Paul went to Ephesus he found people who had been bap-tized but their baptism was unauthorized, so Paul had to baptize them. If they had been baptized by those having authority he would have done as his fellow servants did with the people of Samaria when they received the Gospel: he would have conferred upon them the Holy Ghost. Paul says no man taketh this honor—the authority of the Priesthood— except he be called of God as was Aaron, who was called of the Almighty, through Moses. The same principle was followed in

the Holy Priesthood, which is after the order of an endless life. By virtue of that Priesthood they preached, baptized, laid on hands, and performed their duties as followers of the Lord Jesus. They were opposed by the world, who loved darkness rather than light, just as they do to-day. If the people repent of their day. If the people repeat of their evil deeds we are authorized to buptize them, and to perform the ordinances of the Gospel. I bear re-cord that those who follow this course, doing the will of the Father, will receive a knowledge of the will receive a knowledge of the truth of the Gospel. Strait is the gate and narrow is the path that leads to eternal life. A great many seem to think that they can come around the corner and get in at the gate. But they will find this a roundabout way, and will have to walk the narrow path if they ever do get into the Kingdom of God.

It is over sixty years since this church was organized. We have been commanded to warn the people of the judgments to come, and we have done so. The judgments of the Almighty will be poured out upon those who are wicked, and He will prepare the way for a rule of righteousness. We do not say that those who differ from us will be consigned to an eternal hell, without any hope of receiving the truth. Jesus went and preached to the spirits in prison, that they might receive of the Gospel, live according to God in the spirit, and be judged according to men in the flesh. This Gospel plan embraces all those who will receive salvation. The time will come when the Lord will labor with mankind till every knee shall bow and every tongue confess that Jesus is the Christ. They will also know that Joseph Smith was called of God.

I know this to be the work of Jehovah, and that Joseph Smith was His Prophet. Many young people here seem to wonder whether their fathers are mistaken. I testify that we are engaged in the work of God, and that He will establish it. The Saints have been driven from their homes heretofore, but they will never he driven from these valleys. We may have a great deal of trouble but the Lord will maintain us for the establishment of His purposes. May God bless us and sive all who love the truth.

ELDER EDWARD STEVENSON

It should be as in the days of Noah; that the inhabitants of the earth should be visited with destruction, unless they rendered obedience to the laws of God. The signs of the coming of the Lord are being made manifest in our day, therefore we know that His coming is nigh. The L rd is warning the people of the wrath to come. He raised up a Prophet in this dispensation for this work, which is being carried on. He made the same promise that was made anciently, that those who did the Father's will should know of the truth of the Gospel. The principles revealed to him ware the same se those the Gospel. The principles revealed to him were the same as those taught anciently. They are the everlasting Gospel. The Almighty gave the authority to promplate those principles, and to act in the ordinances of the Gospel, and this authority is today with the Church of Jesus Christof Latter-day Saints. PROSECUTIONS IN IDAHO.

The anti-"Mormon" crusade has been on again in Idaho, and where "Mormons" are arrested the accusation means conviction. During the cases recently tried at Blackfoot, it was the talk about town that the trial jurors were pledged to convict whoever the district attorney wanted them to, evidence or no evidence.

There was one defendant who pleaded guilty to unlawful cohabi-tation. This was James H. Mason, of Egin, Bingham County. Two others—W. C. Martindale, of Cassia County, and John D. Jones, of Ma-lad—were tried, and though there was practically no evidence against them, they were convicted. A case of a similar nature was that against Bishop Jonah Evans, of Samaria, Oneida County, who was found guilty of unlawful conabitation.
