SPECIAL SESSION IS CALLED FOR

Faculty Representatives From the Big Eight Colleges to Meet in Chicago This Winter.

NO MORE FOOTBALL IN GOTHAM SCHOOLS

Col. Robt. Thompson, Himself an Athlete of Wide Note, Suggests Substitution of Lacrosse.

Following the action of the board of superintendents recommending that football be abolished in the public schools of New York, a letter was written to Supt. Maxwell by Col. Robert M. Thompson yesterday, suggesting lacrosse as a substitute, says the New York Herald.

"Lacrosse is a fascinating and graceful game, requiring one to be fleet of foot, quick of eye, to possess good judgment in the passing of the ball, or what is known as team playing, and it has none of the physical dangers of football."

"In order to promote this purely American game it will give us great pleasure in offering competition among the school boys of the boroughs of Manhattan, Brooklyn, Queens, the Bronx and Richmond a championship prize, such as a bronze figure, a banner suitably inscribed to be the property of the winning school, and a gold medal to each member of the winning team, and the proper number of substitutes."

"As I leave in a few days for Europe to be gone some months, I will authorize Mr. A. H. Curtis, of the New York Athletic club, to act for me in the arrangement of the details. The school football would be abolished in all the public schools at the board of education meeting on the 15th of December."
