

TELEGRAPHIC. EASTERN SITUATION.

Negotiations for Peace Upon Certain Conditions.

GREEK LIFE FOR REVOLUTION.

Threats Last an Account of the Conditions and Situation of the Country.

ATHEM, May 10.—The conditions imposed on Greece by Germany, the chief of which is that Greece shall give her autonomy under Greek rule, will be accepted by the Greek government. The point of the power has not yet been issued, but it has been drawn and is to the following effect: Upon a formal declaration by Greece that she will recall her troops and agree to such an autonomous regime for Crete as the powers to their wisdom shall deem best, and accept unconditionally the autonomy of the island, they will intervene in the island of Crete.

The note will probably be presented tomorrow, after the German minister has received final instructions. It is understood that Greece is ready to accept in all of these conditions.

At 6 p. m.—M. Ralli, premier, and M. Skoufopoulos, minister of foreign affairs, had a long interview with the English minister, Lord Salisbury, which has caused considerable comment. It is believed to be connected with the expected intervention of the powers.

THE SULTAN'S SYMPATHY.—LONDON, May 10.—According to the Exchange telegraph, private dispatches received in London from Constantinople declare that the sultan has expressed deep sympathy for King George and the Greek cabinet, whose issue, in his opinion, were forced by revolutionary agents at Athens and Alexandria.

The sultan, according to these dispatches, declines to claim a war indemnity, and proposes a "Terno-Greek" treaty upon the simultaneous evacuation of Thessaly and Crete.

Finally, it is said, the sultan declines to deal directly with Greece and not through the powers.

THEM PREPARING TO ADVANCE.—LONDON, May 10.—Apart from the peace negotiations, the principal feature of the Eastern situation is that Turkey is preparing reinforcements forward and preparing for a rapid advance.

Under the circumstances, it is quickly arranged a settlement of the Greek army is uncertain, but roughly speaking, the first line of defense extends from Ambracia to Lucca, the second follows the old frontier, and the third is down at Thermopylae.

Fighting is probable within the next few days unless the Greek army retreats. The Greek fleet is at Salamis and the transport and other services are still efficient.

The Daily Mail's correspondent at Berlin says it is reported there that the king of Greece has summoned M. Delandras, in view of a possible outbreak.

CONSTITUTIONAL FATAL BLENDED.—LONDON, May 11.—The Athens correspondent of the Daily Chronicle says: The real and only cause of the Greek crisis is the fact that the sultan has refused to accept the autonomy of Crete.
