Receiver Appointed for the Narrow Gauge Road.

DEFAULT IN PAYMENT OF INTEREST

The Petition Brought in the Third District Court by the Central Trust Company.

This afternoon in the Third district court a petition for receivership was filed by the Central Trust company of New York against the Utah Central Railway company, and James Zion, appointed in accordance with the condition, James McGregor, Clarence, Harry of the defendant's property, as receiver of the defendant's property, as described in the bill of complaint, viz., the railroad and its branches, tracks, rolling stock, locomotives, engines, tools, books, documents and other property constituting the management of such railroad, and the defendant's officers and agents, are enjoined and restrained from interference with the receivers and the property under their control.

The history of the first mortgage bonds and the holders of the trust deed have since, owing to default of payment of interest, November 1st, 1892, and since that date,

Look here that, in 1621, Scott "composed some leisure hours with writing a series of 'private letters,' which have been given to the public in the records of a notable family, and giving an account of manners in town and country to the early part of the reign of James I. These letters were printed as fast as I can passim them (this, by the way, is not quite true), in a handsome quarto volume, and I am sure the original workman of this edition, with his numerous corrections and additions, did a great service to the author.

A spiritual institution is the gymnasium-theological institute of Skellefteå, which obtained a state grant in 1878.
