TERRIFIC EXPLOSION.

Peter Peterson Shockingly Mutilated by

Glant Powder and May Die. Vernal Uintah Co., Feb. 12.—Word has reached here from Chipeta, 10 miles above Ouray, of an explosion on the canal being constructed there, in which Peter Peterson was dangerously, and perhaps, fatally, injured, and John Wardle also seriously wounded. A telephone message from Ouray brought the news of the affair, and contained an urgent call for medical assistance.

contained an urgent call for medical assistance.

From what can be learned of the affair, says the Herald correspondent, it seems that Peterson and others were working on the White River canal, where rock has been encountered, and it has been found necessary to blast with giant powder. An ordinary black powder can had been kept partly filled with water, which was used to thaw out the powder, until it had become strongly impregnated with nitroglycerine. Peterson had been sharpening a drill and stuck it down through glycerine. Peterson had been sharp-ening a drill and stuck it down through the ice that had formed over the water to cool it, when there was a terrific explosion. Peterson was thrown fif-teen feet in the air by the force of it, and Wardle, who was standing several feet away, was knocked down. The can was torn into fragments, and the flying pieces tore all the flesh

The can was torn into tragments, and the flying pieces tore all the flesh away from the unfortunate Peterson's face and one side and leg. It tore all the clothing from his body, leaving them a heap of rags. Wardle's hat was knocked from his head and torn to the state of the same and with only one to pieces, but he escaped with only one cut on the face, but is very sick from the effects of the terrific jar he received. It has been cut into small lots to prevent land sharks from getting hold of the land for the purpose of specula-tion. The canals run in every direction and are one-half mile apart. The water will cost not more than \$26 an acre, payable in 10 annual payments, with-out Interest. The government insures a sufficiency of water, and will keep the canals in repair for a period of 10 years, when they will be turned over to the land owners with a clear title

to land and water.
The climate here is much milder than it is in southern Idaho, and is some-what milder than it is in Salt Lake val-ley. Hay,grain, potatoes, in fact all kinds of general crops, do well here. Vege-tables grow in abundance. Fruit such tables grow in abundance. Fruit such as apples, peaches, piums, pears, apricots, prunes and berries of various kinds grow nicely; also the hardy varieties of grapes. Sugar beets have been successfully raised on a small scale, All crops that are planted here yield well, and there is a good market for all that can be raised, at full prices. Good well water can be secured anywhere in the valley at a depth of from six to 15 feet. The valley is about 30 miles square, and is what is known as the Carson Sink. 
