

## PRIVILEGED COMMUNICATIONS

Information Imparted to a Stenographer by an Employer Held Not to be One.

### SO DECIDED IN FORD CASE.

But Examination of Miss Celia McDermott Developed Nothing of Value.

San Francisco, Oct. 1.—That information imparted by an employer to a stenographer is not confidential under the provisions of the political code, when it relates to the proposed commission of fraud or crime, was decided this morning by Judge Lawlor. In overruling an objection interposed yesterday by the T. J. Ford defense to the questioning of Miss Celia McDermott, Gen. Ford's stenographer. The court having ruled, the examination of Miss McDermott was resumed, but brought out nothing of value to either side. Miss McDermott declared that she "tended to her own business and knew nothing else."

The prosecution called George Francis, chief clerk of the law department of the United Railroads, and assistant to Ford. He was asked by Mr. Heney whether he had not, in May, of 1906, seen on top of Gen. Ford's roll desk, two long, narrow packages of bank notes. He denied it. He said the name of Abraham Ruef was not on the payroll of the company's law department, nor was there on the payroll any "John Doe" or "Richard Roe."

The prosecution called for the books of the United Railroads and the defense made a vigorous and prolonged effort to keep them out of court on the score that they were unwilling to have them subjected to the inspection of Rudolph Sprengle, who was characterized by Atty. Rogers as the company's financial and personal enemy.

Judge Lawlor ruled that the books be produced and assured the defense that he would protect the property rights of the corporation as provided by law.

He then informed the defense that the prosecution will conclude its case this afternoon with the exception of the testimony of Abe Ruef, who will be called tomorrow morning.

When court reassembled at 2 o'clock a further adjournment was taken until tomorrow morning.

### LAND FRAUD CASES.

Many Parties Charged with Conspiracy Cannot be Held.

Milwaukee, Wis., Oct. 1.—Government attorneys engaged in prosecuting the so-called land fraud cases under indictments returned in Denver, in connection with the operations of the Federal Coal & Iron company, announced today that they were convinced of their inability to hold J. J. Rosenberg, charged with conspiracy, and that he will probably be discharged by United States Commissioner Bloodgood. It is expected that similar action will be taken with Charles S. Carter, C. E. Canright, Walter S. Johnson and Henry J. Wehr, stockholders in the Wisconsin Coal and Iron company. Atty. Gen. Knobel asked for Rosenberg's discharge by the commissioner, who ruled that he could not discharge him until after he had heard all of the testimony.

### BIG FIRE AT LEADVILLE.

Leadville, Colo., Oct. 1.—Half a dozen business buildings on Harrison avenue and State street were destroyed this morning by a fire supposed to have been caused by the explosion of a gasolene lamp. The property loss is estimated at \$150,000, and there was but little insurance. Miss Mary Brown and a man named White were severely injured in jumping from the windows to the street.

### JAPAN HAS ORDERED NO BIG GUNS OF KRUPP.

Berlin, Oct. 1.—A member of the board of managers of the Krupp works in an interview today denied the current report that the Japanese government had ordered about 30 naval 12-inch guns of the Krupp works. Japan, he said, had been negotiating for months on the subject of these guns, but contract had not been signed. There is no urgency in the matter and Japan may decide to wait until her orders can be filled at the English gun works.

### NEWSBOYS' LAW.

New York, Oct. 1.—A new law by which boys under the age of 14 are prohibited from selling papers between 10 p. m. and 6 a. m. goes into effect today. Boys who violate the law can be arrested either by policemen or transient officers. Boys under 10 are not allowed to sell at any time, while those between 10 and 14 have to secure bond.

### STANDARD OIL HEARING.

J. A. Moffett, President of Indiana Concern Before Federal Grand Jury.

Chicago, Oct. 1.—James A. Moffett, president of the Standard Oil company of Indiana, went before the federal grand jury today to explain his public statement that other concerns besides the Standard Oil company had been guilty of rebating with the railroads. A subpoena was issued for F. H. Holland, chief clerk of the Alton railroad. It is declared that if Holland, as agent for the Alton, gives evidence involving the company criminally in other cases than the Standard Oil company, he would obtain immunity for himself, but not for the railroad. The Alton having been granted immunity only on the case of the Standard Oil company.

It was rumored that the summoning of Holland was the result of a statement by Moffett that agents and officials of the Alton were responsible for the rates granted.

### INSURANCE OFFICIALS.

Jerome Summons Them Before N. Y. Supreme Court Criminal Branch.

New York, Oct. 1.—Leading officials of several of the large life insurance companies were summoned by Dist. Atty. Jerome today to appear before the criminal branch of the state supreme court to plead to indictments found against them by the grand jury. Among the officials summoned were Charles S. Fairchild, formerly secretary of the United States treasury and formerly trustee of the New York Life insurance company; George W. Perkins of the firm of J. Pierpont Morgan & Co., formerly vice president of the same company, both of whom are accused of forgery; John R. Hegeman, president of the Metropolitan Life insurance company, accused on seven counts of forgery and three of perjury; Fred A. Burnham, president, George A. Burdick and George A. Ellsberg, formerly vice president, all of the Mutual Reserve Life insurance company, against whom collectively are pending 15 indictments alleging forgery and perjury; Walter R. Gillette, formerly vice president of the Mutual Life insurance company, charged with forgery; and Thomas D. Jordan, former collector of the Equitable Life Assurance society, against whom there are 18 counts alleging forgery and one of perjury.

They are all ordered to appear on Monday.

### OFF FOR HONOLULU.

President of Reorganizing Goes for Purpose of Dedication Church.

Kansas City, Oct. 1.—Joseph Smith, of Independence, Mo., president of the Reorganized Church of Latter-day Saints, left today for a trip to Honolulu, to dedicate a new church in that city. Mr. Smith also will visit several Pacific coast cities in the interest of his church.

### DRUGGISTS IN SESSION.

Denver, Colo., Oct. 1.—Two hundred and fifty members of the National Wholesale Druggists' association were in attendance when President John B. Carey called the convention to order today. The session will continue three days. Among the most important questions to be discussed is the effect of the national pure food law as applied to drugs and proprietary medicines.

### ALTON ANNUAL MEETING.

Chicago, Oct. 1.—At the annual meeting of the Chicago & Alton Railroad company here today, President S. M. Polton presided and \$9,215 shares were voted. Robert Mather was elected to succeed himself and B. A. Jackson as directors, and Edwin Hawley was chosen to succeed E. H. Harriman as chairman of the board. The annual statement for the year ending June 30 shows net earnings of \$4,784,974, an increase of \$1,017,784.

### PENN. GRAFTERS INDICTED.

Harrisburg, Oct. 1.—Ten of the 14 men involved in the graft prosecutions have been indicted by the Dauphin county grand jury on charges of conspiracy. These men are mentioned in six true bills found out of the 22 cases laid before the grand jury. Six cases every man named except four, whose cases may be considered separately.

The indictments are in punishment of Wilson and Coffey's alleged commission of perjury in the trial of General Counsel T. J. Ford of the United Railroads, which is now in progress.

In the Ford trial Wilson and Coffey testified that no promises of take had been held out by Wilson to his fellow members of the board of supervisors. Other members of the board testified to the contrary.

The grand jury also brought indictments against R. Porter Ashe, an attorney of this city, and Luther Brown, a lawyer of Los Angeles; "John Doe," "Richard Roe" and "Row Doe," who were accused of kidnaping Fremont Older, managing editor of the San Francisco Bulletin, who was arrested in this city last Friday night on a charge of criminal libel preferred by Brown's brother in Los Angeles.

Older was released at Santa Barbara, on a writ of habeas corpus. The John Doe and Richard Roe named in the indictments refer to the two chauffeurs who drove the automobiles in which Older and the deputy constables were conveyed from this city to Richmond City, Va. Doe is a detective said to be employed by the United Railroads, and who, it is alleged, was implicated in the arrest of Older.

Superior Judge Coffey fixed the bail of each of the accused at \$5,000 cash or \$10,000 bonds, and bench warrants were issued for all. It is said that Ben Cohn and F. T. Cochran, the two Los Angeles constables who arrested Older, saved themselves from indictment by giving a full testimony before the grand jury.
