

VITAL STATISTICS.  
Classified Report of the Board of Health for the Month of November.

Clerk Fidman of the City board of health has issued a statement of vital statistics for the month of November. The average death rate per 1,000 for the month was 27. The total number of deaths reported were 1,000 more than in the same month last year. Of those who died 22 were males and 22 females. The causes of death are classified as follows: syphilis, 27; diphtheria, 21; constitutional, 20; tuberculosis, 15; circulatory, 12; respiratory, 11; general, 10; urinary, 10; other causes, 8. The world's statistics of the disease were reported as follows: 2,000,000 in all.

The states were Utah 16, other parts of the United States 13, Oregon 26, not stated 1, Nevada 1, and California 1. The cause of death was not known in 1,400 cases.

The county records show that 2,000,000 persons die annually in the United States.

There were 122 deaths of males and 88 females. The annual estimate is that 82,000 persons of all ages and both sexes died of consumption.
