SURVEYING FOR RAILROAD.

It has been learned that when the two outlaws reached a point 15 miles south of Cady in their mad dash for safety they were met by two members of the gang. A hurried conference was held at the mouth of a deep canyon leading back from the county road and, after changing horses, the four men separated. One of the men who participated in the attack on the bank joining one of the men at the canyon, and starting off in one direction, while the other robber joined the second member and together they started out in a different direction.

It has been learned that without a doubt one of the men—the tallest of the two—who killed Middaugh, is a resident of this county, and is well known; also that one of the two men in waiting at the gulch is a resident of Big Horn county.

The identity of these two men is with the sheriff's office for obvious reasons. It is known, however, that the tall man left Curry and his gang at a point southeast of Meeteetse and returned to a locality near Cady. Officers are now on his trail, and he will be arrested shortly.

SHOCKING GUN ACCIDENT.

Nelson Bunnell Killed Through Careless Handling of Gun.
