Complete Annihilation of the Non-Protectionists.

REPUBLICANS WILL ORGANIZE.

The Victory Won by Progress Over Hate and Selfishness.

A MOST REMARKABLE AND HISTORIC MEETING.

Reverberates the Unshakable Strength of Life by the Powers of Old State.

The movers in favor of a Republican organization had not reckoned without their load. They knew what they would have to meet. But they were a set of men who were equal to the occasion that confronted them, and had displayed courage, determination and tact. Last Monday afternoon, when they learned that the meeting they had called for that evening, to organize a young non-Liberal party, would be packed by a hostile mob, they gracefully left the white hall field in the submersion by postponing the purpose of the evening, resolved to fight the impending battle at the great mass meeting where the full strength of both sides must show itself in a fair and final struggle.

Before the front doors of the Theatre were opened a few friends of the move to organize were admitted at the stage door. A number of leaders of the opposition saw some of them entering at this door, and at once raised the banner that the meeting was being privately packed and certain prominent "Liberal" leaders demanded admission also. This was at first refused, but the protest from the opponents was so emphatic that they were admitted and the front doors were thrown open before the hour announced, giving the opposers the more.

The parades and dress circles were quickly filled, and soon after the commencement of the speaking the doors of the first circle were thrown open and it was soon packed. A number of leaders of the opposition took seats on the stage, including Allen, who was in residence, and the chairman.

THE CHAIRMAN.

Population is increasing and our national resources are being developed. New lines are spreading among the people, and we are compelled to all that we can, cannot be delayed. Let us look a little in advance and make wise preparation for the inevitable. It is not better to draw party lines now, than to do it later. We know that when wisdom comes they will be prepared to act intelligently on national questions! Old animosities between the dominant Church and the opposition, largely removed. There is a strong tendency on the part of both classes to unite for the advancement of their material interests. If we do not organize the Republican party now, the Democrats will capture all the state.

Arthur Pratt nominated H. G. Miller as secretary, and only two voices were heard.

W. G. Van Horn said that the call had read, and the request was complied with. The chairman then explained that it was thought proper that two or three men should be present to represent the majority favoring the cause of the meeting, after which a hearing would be given to speakers from the other side.
