The most serious drawback is the comparatively difficult and consequently expensive transportation to the bullion market. d&w

**Not So Much.** It has been generally supposed that the deposit of snow in the mountains is comparatively and unusually large. This is a mistake. Those who are well informed on the subject state that the depth in many of the canyons is not over half what it was last season at this time. It will be remembered that most of the snowfall occurred during the latter part of winter, which is not near so advantageous, so far as reserving the supply is concerned, as when it comes down in the early part of the season. When it falls early it packs hard and dissolves with difficulty. After all then the supply of water for irrigating purposes, in this part of the Territory at least, may not be over plentiful. Cautious reliance, however, may make up the deficiency. d&w
