A NEW ENTERPRISE.
The Sharpe Estate is Organized for a
Variety of Purposes.

JONES CITY, Miss., Sept. 16.—The Sharpe Estate company is the name of an organization which will begin business next month, with a capital \$25,000,000, and will consist of 250,000 shares of stock, \$100 per share.

The proprietors are D. G. Morris, Harry H. Laddie, Frederick W. Morris, William C. Gaines, Charles W. Peacock, of New York City; Francis G. Newland, of Boston; and John C. Morris.

The organization was incorporated under the laws of New Jersey. The objects of the company are very extensive, as is also the territory in which business is to be transacted, comprising

the entire state of Nevada, Maryland and all other states and territories in the Union, as well as foreign countries. Ferries, piers and wharves are to be purchased, property improved, and railroads constructed, harbors of refueling, manufacturing and mining to be erected, canals and dams to be constructed and operated, and agricultural, horticultural and pastoral enterprises to be developed, as well as the building, purchasing and operating of sailing and steam craft in all the channels of trade.
