HEAVY DAMAGE SUIT

Against the R. G. W. Railroad for the Loss of a Leg, Etc.

The suit of Frank Leake vs. the Rio Grande Western Railroad company came up in Judge Kane's court this afternoon.

Powers & Hiles represent the plaintiff; Bennett, Marshall & Bradley for the defendant.

The amount in dispute is \$25,000, and it is a case brought under these circumstances.

The plaintiff, who resides over Jordan, was engaged hunting one at Hingham station in June, 1921, at a point where people are prohibited to deliver their goods.

AN ARREST FOR ADULTERY.

More of the Banks and County Collector Hardy, Hearing Before a Referee, Etc.

This was the second day of the trial in Judge Kane's court of the case of Edward G. Hooper and wife vs. the Salt Lake City Railway company. It is an action to recover \$10,000 damages for personal injuries sustained by Mrs. Hooper while traveling by one of the company's cars on September 19th, 1930. The facts were reported in yesterday's News.

The plaintiff's side of the case having closed yesterday, the taking of testimony on behalf of the defendants began this morning. Among the witnesses was Superintendent Outland, who was examined as to the effect of the sudden reversal of the electric current under certain circumstances. It will be remembered that in this instance the car was started and its motion suddenly checked without notice, throwing Mrs. Hooper from her seat to the ground with much violence, and hurting her badly.

The case went to the jury at noon.

AGAINST INSURANCE COMPANIES.

Judge Hetherington, as referee, has begun the taking of testimony in the action brought by John Southworth against the Syndicate and three other insurance companies, to recover the sum of \$5000. It is alleged by a plaintiff that he was the owner of a flour mill at Tooele which was insured with the defendant companies. The mill took fire and burned down, and is upon the payment of the money due on the policy that this litigation has arisen.

AMENDED FOR ADULTERY.

About 9:30 this morning Deputy Marshals Will Goodall and Charles Goodall, arrested at the residence on West Ninth South street, on a charge of adultery. An indictment was found against him by the late grand jury. The defendant was formerly a bartender at Schrade's saloon on Main street. Judge Kane had fixed Hagan's bond at \$1000 and this morning the defendant went before Commissioner Greenman as to the matter of furnishing sureties. He was refusing to do so, with a deputy by his side, trying to find "friends in need." The defendant has only just been released from the county jail, and two of his children are still sick with the same illness.

The woman in the case has not yet been arrested.

MORE FURNISHING BANKS.

The Commercial National bank, the Utah National, the State Bank of Utah and the National Bank of the Republic have this morning filed suits in the Third District court against the defendant, restraining County Collector Hardy from collecting taxes upon the stock of these several corporations named, on the ground that it is secured at full cash value, while all other stock of property are assessed at 50 per cent lower. These parties claim that the demand made upon them is inequitable, unjust and illegal, and the proceeding void.

The hearing on the complaint will probably be held when the cases of the other banks are taken up.

ON A PROBATIONARY NOTE.

Montgomery, Nov. 22.-Allen Harrison, age 21, was hanged here this afternoon for the murder of his sweetheart, Bettie Adams, the daughter of a well-to-do farmer, last April. The execution took place in a field two miles from jail. Ten thousand people witnessed the hanging. He murdered the girl because she repelled his advances. Shortly before the hanging he made a statement, that he had no recollection of the murder and he supposed that if he did it, it was while under the influence of morphine.
