

COUNTY BONDING ELECTION

The County Court Issues an Address to the Taxpayers.

WHAT THEY WANT \$300,000 FOR. Completion of the Joint City and County Building and Numerous Other Matters.

On March 10th a resolution was adopted by the county court providing for the submission to the tax-payers of the county the question of whether or not the county should issue bonds to the amount of \$300,000, payable in twenty years after date, and bearing interest at the rate of five per cent per annum, to be used for the construction of the new county court house and additional public and sanitary buildings for Salt Lake county, and for making other necessary county improvements, and to fund the existing indebtedness of said county.

On January 1st of this year, and upon the adjournment of the present county court, the reports of the county clerk and treasurer showed a balance in hand to the credit of the general fund of \$2,070.45. After making the appropriations for December, 1892, and for January and February of this year, there was not only a sufficient balance to meet the ordinary current expenses, but a surplus of \$7,481.52.

In this connection we direct attention to the fact that until the payment of taxes in the last fall there will be no material revenue with which to make good the deficiency thus shown, and to meet the ordinary current expenses, but absolutely nothing with which to pay the county's proportion of the expense of presenting a bill on the joint building, equipping and furnishing the same, paying necessary settlements of the poor farm, improving the jail, reconstructing the building bridge in the way of general personal improvements. Of the first and most important of these, prospective attention upon the county's property in that of presenting a bill upon the joint building.

In the latter part of 1888 automobile arrangements were made jointly by the authorities of Salt Lake City and the county court for the erection of a joint building suitable for the present necessities and future needs of the municipality and the county. As at first agreed upon, the building was to be erected upon ground owned by the city and located at the corner of First South and First East streets, and for a half interest therein the city would pay to the county the sum of \$11,000. After adopting plans, paying architects, making excavations and erecting the foundation for the building at this place, it was decided to change the location to what is known as the Eighth Ward square, and to this the county exchanged its interests in the latter site. The contract for the building was in course of construction to the amount of \$237,977, one-half of which amount is to be paid by the county, viz., \$118,988.50. But since the commencement of the building a change was made in broadening and deepening the foundation, and an additional cost of labor, concrete, iron and other materials, in that respect, amounted to \$2,929.37. Changes from materials to Minnesota granite and additional extra-entences has caused an additional expense of \$20,000. A piece of ground in the adjoining block and immediately east of that upon which the joint building is being erected, and upon which it is intended to locate the heating and lighting plant, was purchased at an expense of \$7,000, and the cost of the building, with other changes, will be \$412,716.27, the county's half amounting to \$206,358.13, and the amount the county has paid \$127,490. Without cost there will be other and further changes and additional extra-entences to the additional cost of the building.

The following are the court's estimates of the amount yet necessary to complete, equip and furnish the joint building, and are made from the best information obtainable from conversations with city members of the looking committee, the architects and from material men:

Expenses in the establishment and equipping of new roads, and in maintaining and repairing the same, established highways, and in equipping and building bridges, are almost wholly dependent upon an adequate vote on the question of issuing bonds. The county court is of the opinion that no more has been appropriated for roads and bridges during the past several years than should naturally be expended for like purposes during the present year and for a number of years yet to come. More road work is immediately required in the western and southern parts of the county, and with-out it will be difficult to carry on business with any degree of efficiency. It is therefore the opinion of the court that the issue of bonds for the purpose of providing for the construction of roads and bridges would be of the most permanent character, which means greater safety at the time and economy in the long run. As to the matter of bridges, it should be recalled with iron structures followed upon similar institutions.
