Wanted Wives.—Miss Allen has filed suit in Commonwealth's Lawyer against John Anderson, the body-snatcher who had sold her to his body-snatching partners for \$100 and demanding \$250 redress.

The complaint charges the defendant with negligence and the new partner to be inimical one who is about to be married.

As a passenger train was approaching Rawlins, Wyoming, a day or two ago, a 12-year-old boy named Charles, a son of a Chinese, one of their number, had been sentenced to six months imprisonment for carrying concealed weapons and five more in the city prison awaiting trial. Only one of the Chinese men who were with him during the trial was then released under bonds, though influential members of the white neighborhood took every possible means to secure their temporary freedom. The other Chinese, however, were anxious to maintain their fighting strength. The Chinese captain had at least found an opportunity to show his power against the lighter-skinned. He was anxious to return to his home after his release and had been held by the station masters and the See Up Gang and the Yee Tong men had refused to settle their differences in a peaceful way. The court concluded that the Chinese had been too active and received a sentence of six months.

One Chinese is in jail for carrying concealed weapons. The other has not yet been released and one Chinese has been released on bail.

The old Chinese mining camp seems to be trying to make new life, and is trying to get to the front, says the Kingdom (Idaho) Advocate. The latest report from others states that John Goss, the military leader of the Chinese Camp, has come to the White Cloud mine.

The White Cloud mine was the first location made in the old camp, and yet may be the last to concentrate the staying qualities.

Articles of incorporation have been filed at Phoenix, Arizona, by the stockholders of the Phoenix Mountaineer and Miner, with a capital stock of \$1,000,000, and it has already been issued. The investors are local and Massachusetts men. The proposed line is to be nearly five miles in length, and will take in all the principal towns in the state. The work of construction will begin immediately.

The Horace Greeley.—An "Chicago" son of Joseph Hale, was driving a forty-horse team of grain to Marquette Lake this morning, but the team and wheel passing over his body just above the heart, he died on the spot.

After being buried in the cemetery at Chippewa Falls, the coroner's inquest showed the upper part of the thigh bone crushed, the liver, kidneys and intestines badly broken. Internal hemorrhage occurred and he succumbed.

The Sibley people say the Laramee Indians are indignant over what they alleged were unkind treatment in the course of their imprisonment and pay-off which was found out two miles from Sibley's ranch, near Sand Creek pass, Colorado, about three weeks ago. The man undoubtedly died from natural causes, but it is claimed that his remains dumped them down hole without even breaking them and stripped of the personal property of the deceased without form of law. When it should have been used to ransom him, he was left alone.

The deceased had no known relatives.

David Watson says he experienced a narrow escape when coming from Fort Verde, Arizona, to the Central Pacific the other day. The down train had side-tracked at Berkley awaiting the arrival of the up train and as that train approached the station the down train had to stop and went down the track. The engine had to stop and the rear of the incoming train had, finally, just passed the switch, when the heavy engine with three freight cars rushed into the main track. The rear car, of course, spun, causing the train to stop, and the rear car stopped. The rear car was badly wrecked.—Arizona Republic.
