GEORGIA.

A fatal scamp in iron.
ATLANTA, GA., 9.—The sheriff of Warren county, who accepted a bribe from persons charged with the murder of Senator Atkins, has been brought here in irons and confined in the barracks by order of General Terry. It is reported that the persons who paid the bribe are also to be arrested.

NEW YORK.

Statute to Daniel O'Connell—May anniversary—Peace policy with the Irish—Presentation of medals—Statute to O'Connell—Distinguished ex-ministers coming.
The commissioners of public parks have decided to erect in Central Park a monument to the memory of Daniel O'Connell.
The usual May anniversary began yesterday. The anniversary of the American Seaman's Friendly Society, was commemorated at the Association Hall. Addresses were delivered by Revs. H. W. Beecher, S. H. Tyng and others. The anniversary of the Five Points Industrial School was celebrated at Steinway Hall, with exercises by the children and addresses by Joseph W. Gregory, Jas. H. Choate and others.
The United States Indian Commissioner has called a meeting for May 15th, for the purpose of discussing the President's peace policy towards the red men; they also call on the people throughout the country to form auxiliary associations.
The bronze medal of the French Geographical Society will be presented to the children of the late General Grant, and will be given in Printing House Square, by Captain De Groot.
A party of Boston men, with an equal number of ladies, will start for San Francisco May thirtieth. Governor Claflin, and the Mayor of Boston, and the Mayors of the surrounding towns will be of the party. It has been arranged that the Governor of the States through which they pass shall meet them on the frontier of their States, and escort them through the State.
A daily paper will be published by the party, to be called the "Charles W. Brooks, Cons. of San Francisco, who is here en route for Washington, to advise the President and Cabinet, and the Senators and Representatives to join the party.

LOUISIANA.

The Coming Prize Fight.

NEW ORLEANS, 10.—Mace and Allen both arrived this morning in fine health and condition. Allen will fight at 173, Mace at 183; the latter has a call at 2 to 1. The opinion is that the fight will last an hour and a half. Those best posted think that if it lasts longer Allen will win. A large crowd of prominent sporting men, from all parts of the country, are present, and are arriving by every train to witness the mill. The train starts for the fighting ground at 4 o'clock in the morning, although the precise spot is attempted to be kept a profound secret. It is rumored that it will take place about 47 miles from the city. All arrangements appear to be satisfactory and the fight is certain to take place. Coburn gave an exhibition last night in the Circus Pavilion; a large number were present. He declares that if Mace defeats Allen he will fight the former for five thousand dollars.

MISSOURI.

Bound for Leavenworth.

St. Louis, 10.—Gen. Pope, accompanied by a portion of his staff, left for Ft. Leavenworth to-night, to ascertain what improvements are necessary for the accommodation of the Department headquarters. The General will meet with General Harney, of Kansas, to consult him with regard to the protection of the frontier from Indians.

WASHINGTON.

Proceedings in Congress.

WASHINGTON, 9.—In the Senate a bill was introduced to secure the incorporation of the Kansas and Gulf Railroad Company, and for reimbursing Kansas for money spent in raising and equipping military for service during the rebellion. The bill reducing the tax on having been taken up, Morrill made a long speech in favor of a protective tariff. Wilson reported a bill to regulate the time for the presentation of claims for additional bounty under the act of July 20th, '63. The legislative appropriation bill was taken up. Sundry amendments from the committee on Appropriations were agreed to. Senator Sherman expressed the opinion that the Senate would do nothing with the tariff, but would consider the bill reducing the Internal Tax.
A bill will be introduced into the House to-morrow providing that women shall act as assistant marshals on taking the census.
The Postmaster General says if the franking privilege is abolished he will be able to reduce the letter postage to two cents.
The French engineers of the Memphis and El Paso Railroad have sent a communication to the Senate Pacific railroad committee, which characterizes the whole scheme as a fraud.
The House and committee have agreed to report back the China telegraph bill, with recommendations that no land grant be given.

Boston, 9.—The interior of Paul's Bay State moulding factory, 441 Tremont street, has been destroyed by fire; loss \$24,000, insured \$25,000.

FOREIGN NEWS.

GREAT BRITAIN.

New system of voting.

London, 9.—In the Lords, to-night, the Marquis of Huntingdon examined and refuted the objections to secret voting, and explained the government's plan, which is as follows: The returning officer shall supply tickets, corresponding in number with the counter-forts, to the voter. The latter is to secretly write the name of his candidate and to deposit the same in the ballot box. These ballots, at the termination of the counting, the home office shall open and count in the presence of the candidates, and then seal the tickets and counter-forts separately and return them to the clerk of the crown. Other stringent provisions are also made against bribery. Fawcett rebuked the government for its tardiness in bringing in the bill. Gladstone replied, and the bill had its first reading.
In the Lords, Granville said that no further news had been received concerning the Red River affair.
The Commons' amendments to the naturalization bill were concurred in, and the bill passed.
Sir Edward Mansfield has been appointed to the command of the forces in Ireland.
Crown.—The weather is fine, with promise of plenty of wind to-morrow for the race between the yachts Cambria and Sappho.

WEST INDIES.

Ladies Using their Influence.

HAVANA, 9.—Some of the principal ladies in Puerto Principe have signed an address asking their relations in the insurgent ranks to return and enjoy liberty under the Spanish government.

FRANCE.

The election returns.

PARIS, 8 o'clock p.m.—The returns now foot up, "yes" 7,125,288; "no" 1,455,844. The army as far as known "yes" 219,200; "no" 38,608. It is estimated that without counting the army and navy the government has a majority of over five millions. The military precautions are continued. A council of ministers was held to-day; the Emperor presiding. It is reported that the result is the ministers resigned and that Ollivier is charged with the formation of a new cabinet. The Emperor has complimented the prefect of police for maintaining public order.
Victor Hugo has been cited before the tribunal for an article in the *Rappel*, exciting hatred and contempt for the government.
MIDNIGHT.—This evening barricades were thrown up in the Faubourg du Temple, but were quickly carried by the troops, who, it is reported, fired on the mob. Other quarters are tranquil.
