

Terrible Fire.

EVANSVILLE, Ind., August 3 .- At 1 Friends of the deceased are invited. o'clock this morning a large fire was raging in the lower part of the city. Armstrong & Cratz', extensive lumber yards were burning, and at 3 o'clock twenty acres of lumber were in ruins. The water supply was wholly insufficient. It is thought the loss will reach half a million dollars.

Before the flames were subdued they destrayed the lumber yard of the Armstrong Co., some 2,000,000 feet, the Armstrong saw mill and stables and two dwellings, and the lumber yard of John K. Reith & Son, some 5,000,000 feet; 15 cars of grain on the Peoria, Decalb & Grantsville Railway and a large warehouse containing tobacco, grain and general merchandise. 


