SUCCESS IN VIEW IN BIG PROJECT

League of Commercial Clubs Promises to Receive Widely Distributed Support.

DELEGATES ARE APPOINTED

Responses to Call Indicate That Nearly Co-operation Will Come from Entire State.

The prospect of success in the proposition to effect a working union of the Commercial clubs of the state continues promising. Manager Harris of the Salt Lake Commercial club received yesterday, communications from Tintic, Mt. Pleasant and Weber county commercial clubs stating the scheme was meeting with ready approval in their respective organizations, and notifying Mr. Harris of the appointment of delegates to attend the state convention of Commercial clubs in this city, Dec. 10 next. The names of the delegates are:

Utah—Hon. James P. Driscoll, president of the Tintic Commercial club, and postmaster of Eureka; C. C. Griggs, superintendent of the Uncle Sam and May Day mines, and Secy E. N. C. of the club.

Mt. Pleasant—President, Dr. A. J. Stewart, vice president, Attorney J. W. Cherry, of the local Commercial club, and Editor J. M. Johnson.

Weber—President, J. W. Heywood, Vice President, W. Wright, Secretary, J. L. Reynolds of the Weber club.

OBJECT IS TWO-FOLD.

The object of a state organization is two-fold, viz., to encourage the individual clubs to work for the advancement of their respective communities along all of the lines operating within the sphere of commercial club influence; secondly, to effect a state organization to secure the advantages naturally accruing from united effort where one general aim and purpose is in view, and not the least of these is insurance against the loss of the individual clubs that come from a knowledge of sympathy and support from corresponding bodies in other sections of the state.

CONVENTION PROGRAM.

The convention will be called to order at 10 a. m., on Dec. 10, with addresses of welcome from Gov. Cutler, Mayor Brannstrom and President Harris of the Salt Lake Commercial club. Suitable responses are to follow from prominent delegates. The afternoon will be devoted to discussion of pertinent questions that may be brought up, and on the following day, final papers will be read, with the formation of a permanent state organization. The delegates will be the guests in the evening of the board of governors of the Salt Lake Commercial club at a banquet, so that the occasion promises to close pleasantly and profitably.

OFFICIAL CALL.

The official call for the convention is issued as follows:

A convention of representatives of the commercial and industrial organizations of the state of Utah is hereby called to meet in the Commercial club rooms, Salt Lake City, Utah, December 10, 1908.

This convention is called for the purpose of creating a state league of commercial and industrial organizations, the duty of which shall be to advance by all legitimate means the commercial prosperity and growth of the state of Utah; to promote uniformity in the custom and usages of products, manufacturers and merchants; seek remunerative markets for home products; foster capital and product labor, mutually interested in each other's welfare; encourage manufacturing and commercial information; extend and develop trade, commerce and the arts, manufactures, agriculture, irrigation, merchandising, banking, mining, smelting, live stock and wool-growing pursuits, and to do any and all things necessary to promote the objects of the proposed organization.

Commercial Clubs—Three delegates. Chamber of Commerce—Three delegates. Boards of Trade—Three delegates. Merchants' Manufacturers' Associations—Three delegates. Real Estate Associations, etc.—Three delegates.

These delegates shall be the president, vice president and secretary of the organization taking part in the deliberations and conclusions of the convention, or their duly accredited representatives. The convention will be called to order at 10 o'clock Thursday morning, Dec. 10, 1908, and it is earnestly hoped that the attendance will be complete and full representatives of the varied interests of the state be present.
