

ANOTHER VETERAN GONE. George M. Webster, Civil War and Black

Hawk Soldler, Summoned Home.

West Jordan, Utah, April 4.—Funeral services were held today over the re-mains of George M, Webster, one of West Jordan's oldest and most highly

West Jordan's oldest and most highly respected residents. In his death ou Thursday last, Utah lost her first broom maker, as well as a Civil war and Elack Hawk veteran. George Matthew Webster was born Aug. 28, 1832, at London, England; em-migrated to Illinois in the ball of 1843 with his father and mother and one brother. Lived in Illinois until he en-tered the army to take part in the Civil war. During a forced march he took sick with pneumonia, and on ad-vice of his doctor he returned home. Civil war, During a forced maren de took sick with pneumonia, and on ad-vice of his doctor he returned home, but soon decided to come west. He soon met some people going to Califor-nia, and accompanied them to Utah, with a mule team. He arrived in Salt Lake City, June 10, 1863. Shortly after reaching Utah he came to West Jordan and began to investigte "Mormonism" and finally embraced the Gospel and was baptized by Bishop A. Gardner Jan. 26, 1863, in Jordan river. He start-ed the first broom factory in Utah at West Jordan in 1864. In the spring of 1867 he went to the Black Hawk war, and returned late in the summer. On the 28th of October. 1887, he married Elizabeth Sprattling; they had nine children, six boys and three girls, eight of whom are now living. He also leaves a wife and 16 grandchildren.




