Figuring on Rates to California.—

CHICAGO, May 2.—Director General Davis was summoned before the national commission today to explain why he should not carry out the instructions of the commission regarding the use of plans made by himself and others. This was the first time since the commission was organized that it had called on Davis. The commission had been told that Davis was not to be called on. Davis appeared before the commission this afternoon. He stated that upon the receipt of instructions he had called on the director of the national commission to get the details of the plan. He had taken it for granted that the order was obeyed. President Palmer of the national commission then read a communication from Acting President Pack of the local directory in reference to the discussion had by that body over the plan, and stating that it was on April 29th referred to the commission of administration.

At the meeting the commission had completed the investigation and reported to the national commission that the order extending non-exhibitors' plans should not be a law in any case. This report was not actually received by a large number of the commission, and a heated discussion ensued, as a result of which Commissioner Bates of Kansas offered a resolution declaring that the commission of administration had no jurisdiction over the plan. The resolution was referred to the judicial committee and the commission adjourned.

Plans exhibited today were expected to be the last. The commission had been told that Davis was not to be called on. Davis appeared before the commission this afternoon. IN THE CAPITAL.
Washington, May 2.—An evening paper says abundant reason for the abandonment of the policy of reciprocity under the McKinley bill exists in the compromise reached by the department regarding the ratification of the treaty by the Spanish officials in Cuba. The Spanish government was forced into the treaty by the diplomacy of Blaine, because of fear that if Cuba was not secured, the United States would be deprived of their interest in the United States through reciprocity arrangements with other neighboring countries, they would risk and retreat against Spain.

The Brazilian government is also making trouble over the reciprocity treaty, the article continues. It was understood that when the general scale of tariff reduction in favor of the United States is made the reciprocal scale of Brazilian tariff duties might be raised. Brazil took advantage of this opportunity to raise the tariff duties in such a manner as to reciprocate with the United States.

AN IMPROVED TIDE AFFECTING THE DUTY ON WOOL.
An important ruling affecting the duty on wool was embodied in instructions addressed by Acting Secretary Hamilton of the treasury department to the collector of customs at New York today. The collector was directed to refund to importers the duty on wool which had been paid in accordance with the decision of the supreme court of appeal at New York. The result will be that the duty on wool will be refunded to the importer.
