BUYERS HAVE
FORSAKEN PIT

A Long Spell of Dull Market Days
Is Predicted by the
Brokers.

SALES OF LOWER MAMMOTH.

Stock Forced Down to Low Figure—
May Day Tumbles—Closing
Quotations.

The sales on the floor of the Salt Lake Stock and Mining exchange today aggregated only a little over \$19,000. Sellers were plentiful, but the buying power was limited. As one broker expressed it: "We can look for a long spell of dull market days. The shorts have covered and the only buying we can look for will be from people who believe stocks have come down to bargain prices and this must necessarily come from people who have been shrewd enough to get out from under during the high prices. Those who have lost during the slump—at least, a great many of them, will be out of the market entirely for awhile. We are going to have a long spell of dullness. At any rate there is every indication of it now."

Some forced sales of Lower Mammouth stock that took down the tobacco in a hurry today. The stock opened weak and sold down to 92 cents. May Day fell to 80 cents, Colorado dropped from \$2.50 to \$2.20, but recovered to \$2.25. Sioux Consolidated held fairly steady under the circumstances, while South Columbia came down to 80 cents and Columbus Consolidated found a buyer at \$2.40.

Ohio Copper came out under pressure and 20 shares were sold to one broker not anxious for the stock at \$5.15. Two dollars was the closing bid. The quotations and sales posted at the end of the call were:
