

NOT A CANDIDATE FOR GOVERNOR.

Hon. Thomas C. Callister of Fillmore Puts Quietness on Political Rumor.

SUPPORTER OF E. H. CALLISTER

Issues a Statement to the Public Saying That He Will Not Enter the Gubernatorial Race.

The Salt Lake Tribune this morning published a statement to the effect that Hon. Thomas C. Callister yesterday announced his candidacy for governor. The information appears to have reached Mr. Callister without loss of time, and, addressed to the public, to the effect that he had declined the nomination. For during the day he telephoned to the Deseret News:

"I have just learned this morning that my name has been suggested for governor; that the statement is made that I am a candidate for that distinguished office. The statement is not true. Circumstances are such that I cannot accept the office, wherefore I shall not strive to obtain it. Besides I have pledged my support to Hon. E. H. Callister of Salt Lake, and shall do what I can to secure his nomination. Respectfully,

Inasmuch as the question of relationship between Mr. Callister of Salt Lake and Mr. Callister of Fillmore has been raised, the "News" asked the latter if relationship actually existed, and he replied:

"Yes, we are distantly related; but just what the relationship is we have not yet quite figured out. All we know is that our ancestors lived on the Isle of Man, and that we came originally from the same family."

POLITICAL STRAWS.

A committee on arrangements sat up almost as late as the St. Louis convention to complete the program for the Democratic ratification meeting, which is to take place tonight at the intersection of East Temple and Second South streets. B. H. Roberts, W. H. King and Fisher Harris will be the speakers, while Judge Powers has been invited to prepare an address to be read to the vast audience expected. The speaking will begin at 8:30 sharp.

The Young Men's Democratic club held an enthusiastic meeting last night at the clubrooms in the Jennings block, and received with great satisfaction the report of the notification committee, along with the check for \$1,000 of Samuel Newhouse, president of the club. It was decided to hold the first annual outing at Saltair on Aug. 4, and a committee was appointed to take charge of the affair. The next meeting of the club will take place on July 18.

Congressman Howell is opening up a vigorous campaign by sending to leading Republicans copies of some of the more important speeches delivered in Congress. Accompanying each speech is a note calling attention to the fact that the speeches will enable the recipient to advance the most convincing arguments for Republicanism.

In view of the nomination at St. Louis, it is rather a striking coincidence that just 20 years ago today, Grover Cleveland was nominated for president by the Democracy assembled at Chicago. After that number of years, Mr. Cleveland still barely escaped being a candidate.

DOING THINGS.

Catholic Committee Gets Big Subscriptions From Prominent Citizens.

Samuel Newhouse yesterday subscribed \$5,000 to the fund for the completion of St. Mary's cathedral. In so doing he won the lasting thanks and admiration of the soliciting committee. The gift is especially noteworthy, inasmuch as Mr. Newhouse is not even a member of the Catholic church. He believes simply that the edifice will be a great credit to his adopted home, Salt Lake City.

Right on top of Mr. Newhouse's magnificent act came a check from John J. Daly for \$5,000. Mr. Daly originally contributed \$10,000 to the fund and his supplemental offering is one that fills the committee with encouragement. The committee reports having subscriptions amounting to \$50,000 in lumps of about \$5,000.

JUST FOR PASTIME.

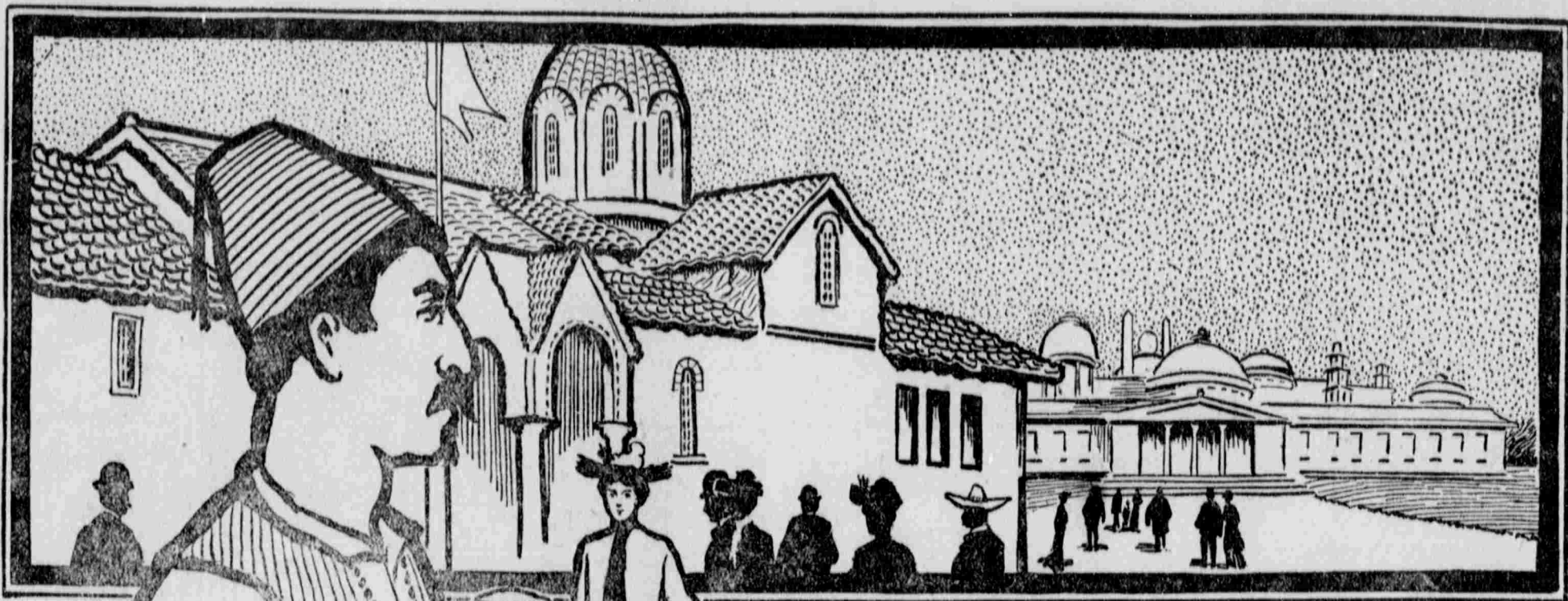
Deputy Sheriff Doing Guard Duty Brings Down an Eagle.

Doing guard duty at the quarantine hospital over a county prisoner who is afflicted with the smallpox, is not monotonous all the time; at least, that is the opinion of Deputy Sheriff Edwards, who was assigned to that duty a week or more ago by Sheriff Emery. The deputy had a little experience several days ago which relieved the monotony of the situation. He saw a large eagle soaring high in the air above the hospital, and, securing his rifle, he gave an exhibition of his marksmanship. At the first shot the eagle fell a few feet but still continued its flight. A second shot from the deputy's rifle brought it to the earth and he now has one of the finest specimens of the eagle ever secured. It measures over five feet from tip to tip of its wings and will be mounted by its owner.
